HOCHTIEF Aktiengesellschaft, Opernplatz 2, 45128 Essen, Germany (the "**Issuer**", and together with its consolidated subsidiaries, the "**HOCHTIEF Group**"), will issue on 28 May 2014 (the "**Issue Date**") EUR [●] [●] per cent. fixed rate notes in bearer form due 2019 (the "**Notes**") with a denomination of EUR 1,000 each. The Notes will be governed by the laws of the Federal Republic of Germany ("**Germany**").

This prospectus (the "**Prospectus**") constitutes a prospectus within the meaning of Article 5.3 of the Directive 2003/71/EC of the European Parliament and of the Council of 4 November 2003 (as amended, *inter alia*, by Directive 2010/73/EU) (the "**Prospectus Directive**"). This Prospectus will be published in electronic form together with all documents incorporated by reference herein on the website of the Luxembourg Stock Exchange (www.bourse.lu).

This Prospectus has been approved by the *Commission de Surveillance du Secteur Financier* of the Grand Duchy of Luxembourg (the "**CSSF**") in its capacity as competent authority under the Luxembourg law relating to prospectuses for securities (*Loi du 10 juillet 2005 relative aux prospectus pour valeurs mobilières*), as amended, (the "**Luxembourg Prospectus Law**"), which implements the Prospectus Directive into Luxembourg law. Pursuant to Article 7(7) of the Luxembourg Prospectus Law, by approving this Prospectus, the CSSF gives no undertaking as to the economic and financial soundness of the transaction and the quality or solvency of the Issuer. The Issuer has requested the CSSF to provide the competent authorities in Germany, Austria and The Netherlands and may request to provide competent authorities in additional host Member States within the European Economic Area with a certificate of approval attesting that the Prospectus has been drawn up in accordance with the Luxembourg Prospectus Law (the "**Notification**").

Application has been made to the Luxembourg Stock Exchange for the Notes to be admitted to trading on the Luxembourg Stock Exchange's regulated market and to be listed on the official list of the Luxembourg Stock Exchange (the "**Official List**"). The Luxembourg Stock Exchange's regulated market is a regulated market for the purposes of Directive 2004/39/EC of the European Parliament and of the Council of 21 April 2004 on markets in financial instruments, as amended.

The issue price, the aggregate principal amount of Notes to be issued, the number of Notes to be issued, the interest rate, the issue proceeds and the yield will be included in the Pricing Notice (as defined in "SUBSCRIPTION, SALE AND OFFER OF THE NOTES" below) which will be filed with the CSSF and published on the website of the Luxembourg Stock Exchange (www.bourse.lu) on or prior to the Issue Date of the Notes.

The Notes have been assigned the following securities codes: ISIN DE000A12TZ95, Common Code 107167340, WKN A12TZ9.

The Notes have not been, and will not be, registered under the United States Securities Act of 1933, as amended (the "Securities Act") and the Notes are in bearer form that are subject to U.S. tax law requirements. RISK FACTORS

*Before deciding to purchase the Notes, investors should carefully review and consider the following risk factors and the other information contained in this Prospectus. Should one or more of the risks described below materialise, this may alone or in combination with other circumstances have a material adverse effect on the business, cash flows, results of operations and financial condition of the Issuer and the HOCHTIEF Group. Moreover, if any of these risks materialise, the market value of the Notes and the likelihood that the Issuer will be in a position to fulfil its payment obligations under the Notes may decrease, in which case the holders of the Notes (the "**Holders**") could lose all or part of their investments. Investors should note that the risks discussed below may not prove to be exhaustive and, therefore, may not be the only risks to which the Issuer and the HOCHTIEF Group are exposed. Additional risks and uncertainties, which are not currently known to the Issuer or which the Issuer currently believes are immaterial, could likewise impair the business operations of the Issuer or the HOCHTIEF Group and have a material adverse effect on their business, cash flows, financial condition and results of operations. The order in which the risks are presented does not reflect the likelihood of their occurrence or the magnitude of their potential impact on the cash flows, results of the operations and financial condition of the HOCHTIEF Group.*

Words and expressions defined in the section "Conditions of Issue" below shall have the same meanings in this section of the Prospectus.

RISKS RELATING TO THE HOCHTIEF GROUP AND THE ISSUER

The Issuer's majority shareholder, ACS, Actividades de Construcción y Servicios, S.A., together with its subsidiaries, could influence the Issuer's business activities.

According to communication received by the Issuer from ACS, Actividades de Construcción y Servicios, S.A., on 16 April 2014 ACS, Actividades de Construcción y Servicios, S.A. held, directly and/or indirectly through its subsidiaries (together the "**ACS Group**"), 58.92 per cent. of the Issuer's share capital. With this shareholding, the ACS Group holds the simple majority of the votes at the Issuer's general shareholders' meetings. Therefore, the ACS Group is in a position to have resolutions passed which require a simple majority of the votes cast at the shareholders meeting. With this shareholding, the ACS Group can further block decisions proposed by the Issuer to its shareholders requiring a 75 per cent. majority. Such decisions include, but are not limited to, certain corporate actions (such as capital increases under the exclusion of subscription rights). This enables the ACS Group – subject to certain restrictions under German corporate law – to exert considerable influence in the Issuer's general shareholders' meetings.

Depending on the actual presence of shareholders at the Issuer's general shareholders' meetings, with its 58.92 per cent. shareholding the ACS Group may also hold a majority of 75 per cent. or more of the votes present or represented at the Issuer's general shareholders' meetings. This would enable ACS Group to vote in favour of decisions requiring a 75 per cent. majority of the share capital present or represented at the shareholders' meeting, such as the conclusion of a profit and loss transfer agreement (*Gewinnabführungsvertrag*) and/or a domination agreement (*Beherrschungsvertrag*). Also, it cannot be excluded that the ACS Group might further increase its holding in the Issuer's share capital in the future,

The market perception of the HOCHTIEF Group's creditworthiness could be adversely influenced by the credit profile of the ACS Group and the possible combination of the credit exposures of the ACS Group and the HOCHTIEF Group by certain banks irrespective of the existence of a profit and loss transfer agreement and/or a domination agreement. Such deterioration of the HOCHTIEF Group's perceived creditworthiness could limit the HOCHTIEF Group's ability to obtain future financing or to obtain such financing on favourable economic terms.

In geographical regions where both the ACS Group and the HOCHTIEF Group are active, the HOCHTIEF Group may be excluded from tenders if both the ACS Group and the HOCHTIEF Group separately participate in such tender processes.

The realisation of any of these risks could have a material adverse effect on the HOCHTIEF Group's cash flows, financial condition and results of operation.

The Issuer is a holding company and its ability to serve its payment obligations depends on the receipt of funds from its subsidiaries and participations.

The Issuer is a holding company with no significant assets other than its interests in its subsidiaries and participations. Its ability to serve its payment obligations mainly depends on the receipt of sufficient funds from its subsidiaries and participations which in turn depends on the business, financial condition and results of operations of these subsidiaries and participations. In particular, the Issuer receives funds in the form of dividends and returns

on shareholder loans from its participation in Leighton Holdings Limited and from other subsidiaries and affiliates which have not entered into profit pooling agreements (*Gewinnabführungsverträge*). The transfer of funds from subsidiaries and participations may be or become subject to legal and contractual restrictions, in particular under financing arrangements entered into by subsidiaries and participations. Regarding the intention of the Issuer to divest or find strategic alternatives for certain assets, see "RISK FACTORS, *Failure of the HOCHTIEF Group to find strategic alternatives for its subdivisions HOCHTIEF Projektentwicklung and formart could have a negative impact on the HOCHTIEF Group's business.*", below.

Additionally, the book value of the subsidiaries and participations of the Issuer are subject to regular impairment tests, which may lead to significant reductions of the Issuer's results of operation. In particular, the Issuer sees an impairment risk with respect to its indirect participation in the Habtoor Leighton Group (a 45 per cent. participation of Leighton Holdings Limited) as well as with respect to shareholder loans extended to this company. The realisation of any of these risks could have a material adverse effect on the HOCHTIEF Group's cash flows, financial condition and results of operations.

The HOCHTIEF Group's business is sensitive to changes in the macroeconomic environment and cyclical fluctuations in certain markets in which it operates.

The HOCHTIEF Group is exposed to the general economic risk of the countries and regions in which it operates.

Economical downturn or cyclical fluctuations in these markets can have a distinct impact on consumer confidence, general prosperity and public spending which in turn can considerably decrease demand for the services and products offered by the HOCHTIEF Group. For example, the financial and economic crisis starting in 2008 led to a worldwide economic downturn and also heavily affected the real estate economy and the construction sector on a global basis which is still perceptible.

The deterioration of sovereign creditworthiness and budgetary austerity measures can negatively affect the HOCHTIEF Group's activities in the affected countries. Furthermore, a worsening of the European sovereign debt crisis may lead to the reintroduction of national currencies in one or more Eurozone countries, which could in turn have major and incalculable negative consequences for the HOCHTIEF Group's business operations in such countries.

A prolonged downturn or a worsening macroeconomic environment could therefore have a material adverse effect on the HOCHTIEF Group's business, cash-flows, financial condition and results of operations.

The business of the HOCHTIEF Group is significantly influenced by large-scale infrastructure projects.

Large corporate groups and governments regularly award large-scale infrastructure project contracts to companies of the HOCHTIEF Group. Large-scale infrastructure projects in turn heavily depend on the political and/or macroeconomic climate and the amount of public spending on programs to stimulate the construction sector in individual countries. The success of the HOCHTIEF Group's business operations is therefore significantly influenced by large-scale infrastructure projects and by the extent national governments and other public authorities spend money on stimulus packages. A decline in public spending on economic stimulus packages and in awards of large-scale infrastructure project contracts to companies of the HOCHTIEF Group could have a material adverse effect on the HOCHTIEF Group's business, cash-flows, financial condition and results of operations.

Failure of the HOCHTIEF Group to find strategic alternatives for its subdivisions HOCHTIEF Projektentwicklung and formart could have a negative impact on the HOCHTIEF Group's business.

There is currently no certainty whether the HOCHTIEF Group will find strategic alternatives for its subdivisions HOCHTIEF Projektentwicklung and formart, for example strategic alliances. If the HOCHTIEF Group is unable to find strategic alternatives for such subdivisions, this could have a material adverse effect on the HOCHTIEF Group's business, cash flows, financial condition and results of operations.

The HOCHTIEF Group is subject to significant competition in the markets in which it operates.

All of the markets in which the HOCHTIEF Group operates are subject to significant competition and high pressure on prices. A high number of competitors and continuous high pressure on prices in the markets in which it operates could impair the ability of the HOCHTIEF Group to maintain or increase its market share. Moreover, several markets are characterised by low market-entry barriers which may lead to further intensifying competition in these markets. Any of these factors could have a material adverse effect on the HOCHTIEF Group's business,

cash-flows, financial condition and results of operations.

The HOCHTIEF Group's business is subject to changes in the political and legal environment which are beyond its control.

The HOCHTIEF Group is exposed to various political and legal risks in the countries in which it operates which are beyond its control and often difficult to anticipate. Such risks include changes in government policies and regulation, tax laws, embargoes, exchange controls, acts of war, terrorism, international hostilities and outbreaks of diseases. Any of these factors could lead to material business disruptions and could have a material adverse effect on the HOCHTIEF Group's business, cash flows, financial condition and results of operations.

Non-compliance with regulations on public procurement and antitrust rules may adversely affect the HOCHTIEF Group's business.

Particularly in its public private partnership (**PPP**) business, its construction, contract mining and real estate business, the HOCHTIEF Group maintains business relationships with public entities domestically and internationally, such as municipalities, local and national governments and government entities. Contracts with such customers are usually awarded based on public procurement procedures which are designed to foster competition among potential contractors. Likewise, many large-scale construction projects run by private counterparties are awarded in similar procedures. While HOCHTIEF operates and enforces policies to ensure compliance of the HOCHTIEF Group with regulations on public procurement and to avoid anti-competitive behaviour and undue influence on individuals responsible for awarding construction contracts and concessions, non-compliance with applicable rules by individuals cannot be excluded entirely (for example, there is an ongoing investigation with regard to potential anti-competitive behaviour of Leighton Offshore Pte. Limited in connection with work to expand offshore loading facilities for Iraq's crude oil exports). In such cases of non-compliance, the HOCHTIEF Group's business could be severely affected by antitrust investigations and fines, exclusion from public and private procurement processes and other regulatory action. Any such actions could materially adversely affect the HOCHTIEF Group's business, cash flows, financial condition and results of operations.

The HOCHTIEF Group is subject to various laws and regulations relating to the protection of the environment, health and public safety.

The HOCHTIEF Group is subject to various laws and regulations relating to the protection of the environment, health and public safety in the countries in which it operates. The HOCHTIEF Group has incurred, and will continue to incur, significant costs in complying with these laws and regulations. In addition, a failure to comply with any such law or regulation could result in the issuance of fines and penalties or the imposition of other sanctions. This could have a material adverse effect on the HOCHTIEF Group's business, cash flows, financial condition and results of operations.

Adverse weather conditions or natural disasters may negatively affect the HOCHTIEF Group's business operations.

Activities in the construction industry generally decrease during periods of cold or extreme weather (e.g., heavy snowfall, extreme wind or strong rain). The ability of the HOCHTIEF Group to carry out its construction services during periods of adverse weather conditions is considerably impaired. Natural disasters (e.g., the floods in Australia in late 2010 and early 2011 and the volcanic ash cloud in Europe in 2010) may also affect the HOCHTIEF Group's business operations. Adverse weather conditions may occur longer than normal or with unusually high intensity and results and revenues generated in normal periods may not be sufficient to compensate for periods of adverse weather conditions. These factors could have a material adverse effect on the HOCHTIEF Group's business, cash-flows, financial condition and results of operations.

Calculation, pricing and execution risks in particular in connection with large-scale projects could impair the HOCHTIEF Group's business.

A significant portion of the HOCHTIEF Group's project contracts contain fixed prices and completion dates the achievement of which is often protected by contractual penalties for the benefit of the relevant contractual partner. Prices and contractual completion dates are based on a number of assumptions which include, in particular, future economic conditions, raw material prices, prices and availability of labour, equipment and materials, time required to obtain governmental approvals or permits, changes in local laws or regulations, local weather and geological conditions and the timely performance of suppliers and subcontractors. Furthermore, PPP contracts (HOCHTIEF Europe) generally have a very long term and require the HOCHTIEF Group to assume future business growth, cost of operation and maintenance expenditures. If any of these assumptions prove to be incorrect or if the HOCHTIEF

Group is unable to successfully monitor and control any of these factors during the course of a project, the HOCHTIEF Group may not be in a position to complete a project in time and/or within cost estimates, especially in connection with large-scale infrastructure projects, for example the liquefied natural gas (LNG) project Gorgon Jetty in Western Australia. The realisation of any of these risks could have a material adverse effect on the HOCHTIEF Group's business, cash flows, financial condition and results of operations.

Failure of the HOCHTIEF Group's subcontractors to perform as anticipated could have a negative impact on the HOCHTIEF Group's business.

In most projects a large percentage of the total work and services to be rendered by the HOCHTIEF Group are subcontracted. As the HOCHTIEF Group remains responsible for the successful completion of the subcontractors' work towards its contractual partners, it may be subject to significant losses or liabilities if subcontractors fail to perform under their relevant contract with the HOCHTIEF Group. Any such losses or liabilities could have a material adverse effect on the HOCHTIEF Group's business, cash flows, financial condition and results of operations.

The HOCHTIEF Group's various joint ventures or other similar partnerships such as "Arbeitsgemeinschaften" may expose the HOCHTIEF Group to liability.

The HOCHTIEF Group constantly enters into joint ventures and other similar partnerships, such as "Arbeitsgemeinschaften". Partners under such arrangements are usually jointly and severally liable for the obligations to be performed by the relevant joint venture or partnership. As a consequence, if the HOCHTIEF Group's joint venture partners fail to satisfactorily perform their obligations, the HOCHTIEF Group may be required to make additional investments and to provide additional services to ensure the adequate performance and delivery of the contracted services. These additional obligations could have a material adverse effect on the HOCHTIEF Group's business, cash flows, financial condition and results of operations.

The HOCHTIEF Group faces warranty, liability and reputational risks.

Products and services of the HOCHTIEF Group may be defective. This may cause substantial damage to personal property, personal injury or give rise to warranty claims and may result in customers or buyers asserting claims for damages, product liability claims or contractual warranty claims. Some of the defects may only be detected after a long period of time which may impair HOCHTIEF Group's possibility to take recourse against partners or subcontractors. Damage to personal property or personal injury incurred in connection with one of the HOCHTIEF Group's projects could also materially impair the HOCHTIEF Group's reputation. Furthermore, the HOCHTIEF Group may become liable for guarantees issued in connection with certain projects. Although the HOCHTIEF Group has taken out insurance to protect itself against these risks in an amount it believes is appropriate, there can be no assurance that the HOCHTIEF Group will be able to obtain corresponding insurance cover on acceptable terms in the future or that the insurance taken out will provide sufficient cover for all potential claims. This could have a material adverse effect on the HOCHTIEF Group's business, cash flows, financial condition and results of operations.

The HOCHTIEF Group is subject to compliance risks.

In its worldwide operations, HOCHTIEF Group is subject to numerous laws and regulations including antitrust rules and legislation prohibiting corruption and bribery. HOCHTIEF Group seeks to combat economic crime and corruption and has implemented a compliance organisation to ensure compliance with all applicable antitrust, anti-corruption and anti-bribery legislation. Any violation of such rules and regulations could expose HOCHTIEF Group to liability and reputational damage, including but not limited to, investigations, fines and other regulatory action. Any such actions could materially adversely affect the HOCHTIEF Group's business, cash flows, financial condition and results of operations.

The HOCHTIEF Group's business faces risks from potential and ongoing litigation.

The HOCHTIEF Group's construction business is characterised by large-scale projects which are complex, lengthy and often time-critical. Some of the factors that may prevent the HOCHTIEF Group from completing projects in the agreed timeframe are beyond the control of the HOCHTIEF Group, such as adverse weather conditions or unexpected technical or geological difficulties. Furthermore, HOCHTIEF faces warranty and liability risks in connection with its business operations. This may result in lengthy disputes and litigation which could also materially impair the HOCHTIEF Group's reputation. While the HOCHTIEF Group maintains provisions in connection with risks from litigation and regularly monitors the adequacy of such provisions, there can be no

assurance that this will protect the HOCHTIEF Group against all litigation risks.

In September 2011, an arbitration proceeding was initiated against certain companies of the HOCHTIEF Group in connection with its indirect holding in the Budapest Airport. The claim is based on the allegation that a change of control in the Issuer occurred that entitles the claimant under a shareholder's agreement to sell its respective indirect holding in the Budapest Airport to HOCHTIEF AirPort at market value to be calculated using predefined valuation methods. Although the HOCHTIEF Group sold its airport business with economic effect of 1 January 2013, the HOCHTIEF Group still bears the economic risk with regard to the arbitration proceeding, still pending at the date of this Prospectus, and the HOCHTIEF Group vigorously defends itself against the claims raised and intends to do so in the future. There is a risk of individual or other co-shareholders in Budapest Airport consortium filing for arbitration correspondingly.

In connection with construction work for a hydroelectric power plant in Fort Augustus, Scotland, HOCHTIEF Solutions AG and HOCHTIEF (UK) Construction Limited were sued in July 2011 by SSE Generation Limited. SSE Generation Limited sought damages in an amount of up to GBP 170 million for the partial collapse of a water tunnel and the subsequent shutdown of the power plant. HOCHTIEF Solutions AG and HOCHTIEF (UK) Construction Limited initiated adjudication proceedings on the same dispute under the Housing Grants Construction and Regeneration Act, 1996. In late 2011, the adjudicator confirmed that HOCHTIEF Solutions AG and HOCHTIEF (UK) Construction Limited were not responsible for the collapse, and consequently no moneys were due by either HOCHTIEF Solutions AG or HOCHTIEF (UK). SSE Generation Limited challenged the adjudication decision and in late 2012 recommenced legal proceedings, presently claiming approximately GBP 133 million plus interest. The lawsuit is currently pending before the Court of Sessions in Edinburgh. The HOCHTIEF Group currently intends to vigorously defend itself against the claims raised.

In connection with a contract for the transport and installation of tripod foundations and wind energy converters for an offshore wind farm in the German North Sea, HOCHTIEF Infrastructure GmbH referred numerous claims (clustered in packages) to a Dispute Adjudication Board (DAB). The first package mainly concerned delays in connection with the provision of tripods and amounted to EUR 20.27 million. The employer disputed the basis of the claims, in particular the amounts of the claims, and raised a counter-claim for liquidated damages in the amount of EUR 18.6 million. The DAB held that HOCHTIEF's claims are justified at an amount of EUR 8.44 million. However, the DAB also fully upheld the employer's claim for liquidated damages (EUR 18.6 million). HOCHTIEF intends to bring out a notice of dissatisfaction. Whether the case will be referred to an arbitral tribunal has not been decided yet. The second package is based on the employer's postponement of the installation of the wind energy converters and has a volume of EUR 46.36 million. The employer disputes mainly the amount of the claim. The DAB scheduled the oral hearing for mid-June 2014. HOCHTIEF Infrastructure GmbH intends to refer further claims based on disruptions and instructed variations to the DAB totaling to approximately EUR 50 to 60 million.

In connection with a project in Qatar, negotiations for the final account are still ongoing. HOCHTIEF Infrastructure GmbH is claiming QAR 7,920 million (EUR 1,573 million). The employer has offered QAR 7,150 million (EUR 1,420 million), which is falling short of HOCHTIEF's expectations. The next settlement meeting will take place in May 2014. A standing Dispute Adjudication Board is in place.

Furthermore, there is an investigation with regard to potential anti-competitive behaviour of Leighton Offshore Pte. Limited in connection with work to expand offshore loading facilities for Iraq's crude oil exports. The investigation, which was initiated by a report of Leighton Holdings Limited to the Australian Federal Police, is still ongoing at the date of this Prospectus, and the HOCHTIEF Group intends to fully cooperate with the Australian Federal Police.

Any potential and ongoing litigation could have a material adverse effect on the HOCHTIEF Group's business, cash flows, financial condition and results of operations.

The HOCHTIEF Group faces risks in connection with the expansion of its business operations.

In recent years, the HOCHTIEF Group has expanded its business operations considerably, both through organic growth and acquisitions. The expansion of business operations and the development of new markets is associated with certain risks, in particular that the expected growth rates and economic development of new businesses lag behind the target which may lead to a potential partial or complete loss of the capital employed. This could have a material adverse effect on the HOCHTIEF Group's business, cash flows, financial condition and results of operations.

The HOCHTIEF Group is dependent on the efficient and uninterrupted operation of its IT-systems.

The organisation and control of the HOCHTIEF Group's business operations is dependent on efficient and uninterrupted IT-systems. Telecommunication systems are sensitive to power failures, computer viruses, interruptions, fires and similar events as well as to unauthorised use. Interruptions or breakdowns of IT-systems cannot be ruled out and could lead to disruptions of the HOCHTIEF Group's business operations or could otherwise have a material adverse effect on the HOCHTIEF Group's business, cash flows, financial condition and results of operations.

Minority shareholdings or minority board representations might limit the ability of the HOCHTIEF Group to realise its strategic goals in connection with certain investments.

The HOCHTIEF Group holds minority stakes in a number of companies or only holds a minority board representation in some of its subsidiaries and participations. As a consequence, it may only have limited power to influence important decisions with respect to these companies and these companies may take decisions that are unfavourable to the interests of the HOCHTIEF Group. In addition, third parties hold minority positions in some of the HOCHTIEF Group's majority-owned subsidiaries which could result in disadvantages to the HOCHTIEF Group if the interests of minority shareholders are not in line with the interests of the HOCHTIEF Group. This could have a material adverse effect on the HOCHTIEF Group's business, cash flows, financial condition and results of operations.

The HOCHTIEF Group has certain pension obligations which may require additional cash contributions.

The HOCHTIEF Group has pension obligations towards its employees that are based on certain actuarial assumptions which vary from country to country, including discount rates, long-term rates of return on invested plan assets and rates of increase in compensation levels. If actual results, especially discount rates and/or rates of return on plan assets, were to differ from these assumptions, the HOCHTIEF Group's pension, retirement and other post-employment costs could be significantly higher as assumed which may require additional cash contributions. Changes in assumptions and/or under-performing plan assets could also have a material adverse effect on the HOCHTIEF Group's cash flows, financial condition and results of operations.

The HOCHTIEF Group is dependent on being able to hire and retain a qualified management team and skilled employees.

The HOCHTIEF Group's performance depends significantly on the performance of the members of its management team. The HOCHTIEF Group's management team has significant experience in operating its businesses and has made important contributions to the HOCHTIEF Group's growth and success. The ability of the HOCHTIEF Group to increase revenues and profits furthermore depends significantly on the HOCHTIEF Group's success to attract and retain highly skilled employees. Competition for such employees is intense. Failure to hire and retain a qualified management team and skilled employees could have a material adverse effect on the HOCHTIEF Group's business, cash flows, financial condition and results of operations.

Currency exchange rate fluctuations could adversely affect the result of operations of certain parts of the HOCHTIEF Group's business.

The results of operations of certain parts of the HOCHTIEF Group's business are subject to fluctuations of the Euro as the Issuer's functional currency against various other currencies (in particular the Australian dollar and the US dollar). Exchange rate fluctuations may affect the results of operations when cash flows and results of operations of foreign subsidiaries are stated in currencies other than the Euro (translation risk). Fluctuations in exchange rates can also lead to differences between the costs of the goods and services provided and the sales generated from the sale of such goods and services (transaction risk). The HOCHTIEF Group follows a strict hedging strategy to limit the transactional risk resulting from exchange rate fluctuations. However, the HOCHTIEF Group bears the default risk of the relevant counterparty and there can be no assurance that the hedging strategy will always be successful and will protect the HOCHTIEF Group against all exchange rate fluctuations. This could have a material adverse effect on the HOCHTIEF Group's business, cash flows, financial condition and results of operations.

The HOCHTIEF Group is exposed to liquidity risks.

The development of the HOCHTIEF Group's business depends, among other things, on the ability to fund investments and its current business operations areas as well as on its ability to refinance existing financial indebtedness. The syndicated revolving letter of guarantee and revolving credit facility agreement and certificates of indebtedness (*Schuldscheindarlehen*) in place require continuous compliance with certain covenants contained

in the syndicated revolving letter of guarantee and revolving credit facility agreement, including certain financial covenants. There can be no assurance that the HOCHTIEF Group's opportunities for financing and the terms of any financing will not be adversely affected in the future, in particular a prolonged economic downturn like the financial and economic crisis starting in 2008 as well as the current European sovereign debt crisis could significantly impair the HOCHTIEF Group's ability to obtain additional financing or refinancing of its existing facilities at all or at acceptable commercial terms.

In addition, certain subsidiaries and shareholdings of the HOCHTIEF Group will require external financing and/or refinancing of existing external financing during the term of the Notes. Should such financing and/or refinancing not be available or not be available at favourable conditions, significant monetary contributions (such as equity injections or shareholder loans) by the HOCHTIEF Group to such subsidiaries and shareholdings or any other form of assistance by the HOCHTIEF Group in connection with such financing and/or refinancing may be required.

This could have a material adverse effect on the HOCHTIEF Group's business, cash flows, financial condition and results of operations.

Interest rate fluctuations may lead to an increase in the HOCHTIEF Group's financing costs.

The cost at which the HOCHTIEF Group can obtain financing depends on general market conditions, particularly on the development of interest rates and the assessment of the creditworthiness of the HOCHTIEF Group. In the case of deteriorating general market conditions or a deteriorating creditworthiness of the HOCHTIEF Group, only debt financing with higher risk premiums than are currently in place may be available. The HOCHTIEF Group uses interest rate swaps to hedge itself against interest rate fluctuations. However, the HOCHTIEF Group bears the default risk of the relevant counterparty and there can be no assurance that the interest rate hedging strategy will always be successful and will protect the HOCHTIEF Group against all interest rate fluctuations. This could have a material adverse effect on the HOCHTIEF Group's business, cash flows, financial condition and results of operations.

The HOCHTIEF Group is exposed to price risks on the procurement side, in particular with respect to raw materials.

In addition to exchange and interest rate fluctuations, the HOCHTIEF Group is exposed to price risks and unexpected shortages on the procurement side as a result particularly of changes in commodity prices and prices for raw materials and energy. Changes in commodity prices and prices for raw materials and energy could have a material adverse effect on the HOCHTIEF Group's business, cash flows, financial condition and results of operations.

The HOCHTIEF Group faces counterparty risks.

Customers or other counterparties of the HOCHTIEF Group may fail to comply with their payment and other obligations vis-à-vis the HOCHTIEF Group when due, in particular customers that have received services from the HOCHTIEF Group and joint venture partners, partners from other partnerships and subcontractors of the HOCHTIEF Group that are responsible to complete work towards the HOCHTIEF Group's contractual partners. The counterparty risk has been considerably increased by the most recent financial and economic crisis starting in 2008. For example, as a consequence of the global financial crisis, the Habtoor Leighton Group had to negotiate settlements with deferred payment conditions and furthermore faces the risk of a loss of receivables out of certain projects in the United Arab Emirates and Qatar. Additionally, due to an increasing number of large-scale infrastructure projects, especially liquefied natural gas (LNG) projects in Australia, the HOCHTIEF Group may incur significant losses even if only one or very few counterparties fail to comply with their payment and other obligations vis-à-vis the HOCHTIEF Group in connection with such large-scale infrastructure projects. While the HOCHTIEF Group regularly monitors a potential impairment of its claims against third parties, there can be no assurance that this will protect the HOCHTIEF Group against all counterparty risks. This could have a material adverse effect on the HOCHTIEF Group's business, cash flows, financial condition and results of operations.

The HOCHTIEF Group is subject to tax risks resulting from current or future tax audits.

The HOCHTIEF Group companies are regularly subject to tax audits. It is possible that current or future tax audits may result in significant additional tax payments or demands which could have a material adverse effect on the HOCHTIEF Group's business, cash flows, financial condition and results of operations.

RISKS RELATING TO THE NOTES

An investment in the Notes involves certain risks associated with the characteristics, specification and type of the Notes which could lead to substantial losses that Holders would have to bear in the case of selling their Notes or with regard to receiving interest payments and repayment of principal. Risks regarding the Notes comprise, *inter alia*, the following risks:

The Notes may not be a suitable investment for all investors

Each potential investor in the Notes must determine the suitability of that investment in light of its own circumstances. In particular, each potential investor should:

- (i) have sufficient knowledge and experience to make a meaningful evaluation of the relevant Notes, the merits and risks of investing in the Notes and the information contained or incorporated by reference in this Prospectus, the Pricing Notice or any supplement to the Prospectus;
- (ii) have access to, and knowledge of, appropriate analytical tools to evaluate, in the context of its particular financial situation and the investment(s) it is considering, an investment in the Notes and the impact the investment in the Notes will have on its overall investment portfolio;
- (iii) have sufficient financial resources and liquidity to bear all of the risks of an investment in the Notes, including where the currency for principal or interest payments is different from the potential investor's currency;
- (iv) understand thoroughly the terms of the Notes; and
- (v) be able to evaluate (either alone or with the help of a financial adviser) possible scenarios for economic, interest rate and other factors that may affect its investment and its ability to bear the applicable risks.

Liquidity Risk

There is currently no liquid market for the Notes. Application has been made for the Notes to be admitted to trading on the regulated market of the Luxembourg Stock Exchange and to be listed on the Official List of the Luxembourg Stock Exchange. However, there is a risk that no liquid secondary market for the Notes will develop or, if it does develop, that it will not continue. The fact that the Notes may be listed does not necessarily lead to greater liquidity as compared to unlisted notes. In an illiquid market, an investor is subject to the risk that he will not be able to sell his Notes at any time and/or at fair market prices. The possibility to sell the Notes might additionally be restricted by country specific reasons.

Risk of Early Redemption

The Notes may be redeemed at the option of the Issuer (in whole, but not in part) at the aggregate principal amount of the Notes plus accrued interest to the date fixed for redemption for reasons of taxation. In the event that the Issuer exercises the option to redeem the Notes, the Holders might suffer a lower than expected yield and might not be able to reinvest the funds on the same terms.

Market Price Risk

The development of market prices of the Notes depends on various factors, such as changes to market interest rate levels, the policies of central banks, overall economic developments, inflation rates or the lack of or excess demand for the Notes. The Holders are therefore exposed to the risk of an unfavourable development of market prices of their Notes which materialises if the Holders sell the Notes prior to the final maturity. If a Holder decides to hold the Notes until final maturity, the Notes will be redeemed at their principal amount.

The market value of the Notes could decrease if the creditworthiness of the HOCHTIEF Group worsens or is perceived to worsen.

If, for example, because of the materialisation of any of the risks regarding the Issuer, the Issuer is less likely to be in a position to fully perform all obligations under the Notes when they fall due, the market value of the Notes will suffer. In addition, even if the Issuer is not actually less likely to be in a position to fully perform all obligations under the Notes when they fall due, market participants could nevertheless have a different perception. In addition, the market participants' estimation of the creditworthiness of corporate debtors in general or debtors operating in the same business areas as the HOCHTIEF Group could adversely change.

If any of these risks occurs, third parties would only be willing to purchase Notes for a lower price than before the materialisation of the relevant risk. Under these circumstances, the market value of the Notes will decrease.

Currency Risk

The Notes are denominated in Euro. If such currency represents a foreign currency to a Holder, such Holder is particularly exposed to the risk of changes in currency exchange rates which may affect the yield of such Notes in the currency of the Holder. Changes in currency exchange rates result from various factors such as macro-economic factors, speculative transactions and interventions by central banks and governments.

In addition, government and monetary authorities may impose (as some have done in the past) currency exchange controls that could adversely affect an applicable currency exchange rate. As a result, investors may receive less interest or principal than expected, or no interest or principal at all.

Fixed Rate Notes

The Notes bear interest at a fixed rate. A Holder of Notes is particularly exposed to the risk that the price of such Notes falls as a result of changes in market interest rates. While the nominal interest rate of a Note, as specified in the Conditions of Issue, is fixed during the term of the Notes, the current interest rate on the capital market typically changes on a daily basis. As the market interest rate changes, the price of fixed rate notes also changes, but in the opposite direction. If the market interest rate increases, the price of fixed rate notes typically falls, until the yield of such notes is approximately equal to the market interest rate of comparable issues. If the market interest rate falls, the price of fixed rate notes typically increases, until the yield of such notes is approximately equal to the market interest rate of comparable issues. If a Holder of the Notes holds his notes until maturity, changes in the market interest rate are without relevance to such Holder as the Notes will be redeemed at their principal amount.

Risks in connection with the application of the German Act on Debt Securities (Gesetz über Schuldverschreibungen aus Gesamtemissionen)

A Holder is subject to the risk to be outvoted and to lose rights towards the Issuer against his will in the case that Holders agree pursuant to the Conditions of Issue to amendments of the Conditions of Issue by majority vote according to the German Act on Debt Securities (*Gesetz über Schuldverschreibungen aus Gesamtemissionen* - "SchVG"). The rules pertaining to resolutions of Holders are set out in the SchVG and are largely mandatory. According to the SchVG the relevant majority for Holders' resolutions is generally based on votes cast, rather than on the aggregate principal amount of the relevant Notes outstanding, therefore, any such resolution may effectively be passed with the consent of less than a majority of the aggregate principal amount of the relevant Notes outstanding. As such resolution is binding on all Holders, certain rights of such Holder against the Issuer under the Conditions of Issue may be amended or reduced or even cancelled.

In the case of an appointment of a common representative (*gemeinsamer Vertreter*) for all Holders a particular Holder may lose, in whole or in part, the possibility to enforce and claim his rights against the Issuer regardless of other Holders.

Changes in Accounting Standards

The Issuer's consolidated financial statements are prepared in accordance with International Financial Reporting Standards as adopted in the European Union (*IFRS*). New or changed accounting standards may lead to adjustments in the relevant HOCHTIEF Group accounting positions. This might lead to a different perception of the market regarding the HOCHTIEF Group's and the Issuer's creditworthiness. As a result there is a risk that the market value of the Notes might decrease.

No restriction on the amount of debt which the Issuer may incur in the future

There is no restriction on the amount of debt which the Issuer may issue which ranks equal to the Notes. Such issuance of further debt may reduce the amount recoverable by the Holders upon winding-up or insolvency of the Issuer or may increase the likelihood that the Issuer may or shall defer payments of interest under the Notes.

Negative pledge and borrowings not classified as Capital Market Indebtedness

Any borrowings that do not meet the definition of Capital Market Indebtedness are excluded from the negative pledge contained in § 2(2) of the Conditions of Issue. Therefore, in any of these cases the Issuer is under no obligation to grant to the Holders an equal and rateable security. Such transactions may reduce the amount recoverable by the Holders upon winding-up or insolvency of the Issuer.

USE OF PROCEEDS

In connection with the offering of the Notes, the Issuer will receive net proceeds of approximately EUR [●]. The Issuer intends to use these proceeds for general corporate purposes including the repayment of existing debt.

The expenses of the issue of the Notes are expected to amount to approximately EUR 150,000 plus the fees of up to 0.35 per cent. of the aggregate principal amount of the Notes to be paid in connection with the Offer of the Notes to the Managers.

The issue proceeds will be included in the Pricing Notice (as defined in "*SUBSCRIPTION, SALE AND OFFER OF THE NOTES*" below) which will be published on the website of the Luxembourg Stock Exchange (www.bourse.lu) on or prior to the Issue Date of the Notes.

INFORMATION ABOUT THE ISSUER

I. Responsibility Statement

The responsibility statement is set out on page 2 of this Prospectus.

II. General Information

1. History and Development

The Issuer is a German stock corporation (*Aktiengesellschaft*). It is registered in the commercial register (*Handelsregister*) of the local court (*Amtsgericht*) of Essen under registration number HRB 279 and has its registered office at Opernplatz 2, 45128 Essen, Germany (telephone number +49 201 824-0).

The Issuer traces its roots back to the year 1873 when it was founded as a general partnership (*Offene Handelsgesellschaft*) under German law under the name "Gebr. Helfmann". In 1896 it was converted into a German stock corporation.

The shares of the Issuer are tradable via XETRA and in Berlin, Düsseldorf, Frankfurt, Hamburg-Hannover, Munich and Stuttgart.

2. Corporate Purpose

According to section 2 of its articles of association, the Issuer's corporate purpose is the management of a group of companies active, without limitation, in the following areas:

- a) the performance of all kinds of construction work for their own account and for the account of third parties;
- b) the acquisition, sale or other use and the letting of land and buildings and the performance of services in relation to buildings;
- c) the performance of all auxiliary activities relating to the construction trade, including, without limitation, the purchasing, manufacture and utilisation of construction material, plant and equipment;
- d) the design and planning of and the performance of design calculations for works;
- e) the construction and operation of all types of plants relating to environmental engineering;
- f) the construction and operation of facilities designed for passenger and freight transport;
- g) the conclusion and administration of insurance contracts related to construction activities;
- h) the acquisition and administration of participating interests in airport companies and the acquisition of franchises for the construction and/or operation of airports or individual components of airports or the performance of services at airports;
- i) the development and marketing of information and internet technology related to construction and the performance of services connected therewith;
- j) the utilization of patents and other industrial property rights in all areas pursuant to the object of the Issuer;
- k) the acquisition, construction and/or operation of infrastructure systems of all types including traffic infrastructure systems (for example, roads, tunnels, bridges, ports, air traffic and other traffic control systems) and social infrastructure systems (for example, schools, universities, leisure facilities) and the acquisition of concessions

for the acquisition, construction and/or operation of such infrastructure systems and the performance of services in connection with such infrastructure systems;

- l) the chartering of special-purpose vessels for offshore projects.

3. Financial Year and Auditors

The Issuer's financial year corresponds to the calendar year.

The independent auditors of the Issuer are Deloitte & Touche GmbH, Wirtschaftsprüfungsgesellschaft, Schwannstrasse 6, 40476 Düsseldorf, Germany ("**Deloitte**"), a member of the German Chamber of Public Accountants, Berlin, Germany (*Wirtschaftsprüferkammer*). Deloitte has audited the consolidated financial statements of the Issuer for the financial years ended 31 December 2012 and 31 December 2013 and has, in each case, issued an unqualified auditor's report.

4. Major Shareholders

ACS, Actividades de Construcción y Servicios, S.A. ("**ACS**") holds the (simple) majority of the shares in the Issuer and is the parent company of the Issuer.

The Issuer's articles of association do not require shareholders to disclose their share holdings. The German Securities Trading Act (*Wertpapierhandelsgesetz*), however, requires holders of voting securities of the Issuer to notify the Issuer and the Federal Financial Supervisory Authority of the number or shares they hold if that number reaches, exceeds or falls below specified thresholds. These thresholds are 3 per cent., 5 per cent., 10 per cent., 15 per cent., 20 per cent., 25 per cent., 30 per cent., 50 per cent. and 75 per cent. of the Issuer's outstanding voting rights.

The following table sets forth certain information regarding the beneficial ownership of the outstanding ordinary voting shares to the extent known to the Issuer based on latest information available to the Issuer of each person or group known by the Issuer to own beneficially 3 per cent. or more of the outstanding ordinary voting shares.

The Management Board of the Issuer produced a report on relations with affiliated enterprises pursuant to section 312 German Stock Corporation Act (*Aktiengesetz*, "**AktG**") for the period from 1 January 2013 to 31 December 2013, which was audited by Deloitte.

The Issuer is a fully consolidated company of ACS. Since there is no control agreement between ACS and the Issuer, the Issuer is controlled by ACS only insofar as the German Stock Corporation Act permits influence of shareholders in a stock corporation. According to the German Stock Corporation Act, the management board shall have direct responsibility for the management of the company and the management board is not subject to instructions by the major shareholder. However, certain acts require the consent of the Issuer's shareholder meeting and, with its shareholding, the ACS Group is in a position to have shareholders' resolutions passed which require a (simple) majority of the votes cast at the shareholders meeting and the ACS Group can further block decisions proposed by the Issuer to its shareholders requiring a 75 per cent. majority. Other than that, the Issuer is not dependent upon ACS.

As an independent listed group, the Issuer publishes its own consolidated financial statements, which are also included in the consolidated financial statements of ACS.

5. Share Capital

The Issuer's share capital amounts to EUR 177,432,151.04 and is divided into 69,309,434 ordinary bearer shares with no par value. All shares are fully paid up.

The Issuer has a conditional capital of EUR 49,280,000.00, divided into up to 19,250,000 no-par value bearer shares. The conditional capital increase will only be implemented to the extent that the bearers or creditors of option or conversion rights or those with an obligation to convert/exercise options from warrant-linked or convertible bonds, profit participation rights or participating bonds (or a combination of these instruments) issued against cash contribution that were issued or guaranteed by the Issuer or a subordinated group company of the Issuer on or before 11 May 2016 as a result of the authorisation of the Executive Board by way of the resolution by the Issuer's general shareholders' meeting (the "**General Shareholders' Meeting**") passed on 12 May 2011 actually use their option or conversion rights or, to the extent that they are obliged to convert/exercise their options, fulfil their obligation to convert/exercise their options or to the extent that the Issuer exercises an option to grant shares of the Issuer in whole or in part instead of payment of the cash amount due provided no cash compensation is granted or treasury shares or shares of another listed company are used for servicing in each case. New shares are issued at the option or conversion price to be determined in each case according to the authorisation resolution detailed above. The new shares participate in profits from the start of the financial year in which they are created. The Executive Board is authorised, subject to the approval of the Supervisory Board, to determine the further details of the conditional capital increase.

The Executive Board is authorised, subject to the approval of the Supervisory Board, to increase the share capital on or before 10 May 2015 by issuing new, no-par value bearer shares against cash and/or non-cash contributions, on one or several occasions, up to a total of EUR 35,840,000.00 (authorised capital I). The shareholders must be granted subscription rights unless excluded in certain circumstances. The content of the share rights and the further conditions of the share issue including the issuing amount will be decided by the Executive Board subject to the approval of the Supervisory Board.

The Executive Board is further authorised, subject to the approval of the Supervisory Board, to increase the share capital on or before 11 May 2016 by issuing new no-par-value bearer shares against cash and/or non-cash contributions, on one or several occasions, up to a total of EUR 23,296,000.00 (authorised capital II). The shareholders must be granted subscription rights unless excluded in certain circumstances. The content of the share rights and the further conditions of the share issue including the issuing amount will be decided by the Executive Board subject to the approval of the Supervisory Board.

IV. Financing Structure of the HOCHTIEF Group

The Issuer has entered into a long-term syndicated revolving letter of guarantee and revolving credit facility agreement consisting of a EUR 500 million credit facility and a EUR 1.5 billion revolving guarantee facility both expiring in 2019, a EUR 500 million non-rated bond due in 2017, a EUR 750 million non-rated bond due in 2020 and various certificates of indebtedness (*Schuldscheindarlehen*) in an aggregate amount of EUR 422 million due in 2014, 2015 and 2016 of which an amount of approx. EUR 284.5 million shall be prematurely repaid in May 2014. There are also short-term, bilateral, revolving money market facilities with a total facility amount of EUR 337 million, undrawn as of the balance sheet date 31 December 2013. Further loans are in place on a local basis particularly for the HOCHTIEF Group's American and Australian operational units. In the HOCHTIEF Americas business division, the Turner Corporation and Flatiron Construction Corp. retain a USD 6.5 billion bonding facility with six major US surety companies to provide security for predominantly public-sector construction contracts.

V. Business Overview of the HOCHTIEF Group

1. Overview

Based on sales, the HOCHTIEF Group is one of the world's leading construction services groups and represented in all of the world's major markets (*source*: ENR Source Book, September 2013 and ENR Top 250 International Contractors, August 2013). It operates globally via its three business divisions HOCHTIEF Americas, HOCHTIEF Asia Pacific and HOCHTIEF Europe. HOCHTIEF Group delivers complex infrastructure projects, in some cases on the basis of concession models. HOCHTIEF Group operates in the transportation infrastructure, energy infrastructure and social/urban infrastructure segments as well as in the contract mining business. For the fiscal year ended 31 December 2013, the largest markets of the HOCHTIEF Group, Americas (primarily North America), Australia, Asia (including the Gulf states) and Germany, accounted for 97 per cent. of the HOCHTIEF Group's sales. The Issuer, the parent company of the HOCHTIEF Group, is a management holding company and functions as the HOCHTIEF Group's headquarters, performing corporate headquarter as well as worldwide strategic management functions for the HOCHTIEF Group.

The following table shows the sales, EBITDA, order backlog and number of employees of HOCHTIEF Group and divided into the three business divisions of the HOCHTIEF Group for the three month period ending 31 March 2014 and for the fiscal year ended 31 December 2013.

Potential investors should take into consideration that this figure by itself is not a basis to compare different companies. Furthermore it does not substitute the financial key figures of the consolidated statement of comprehensive income and the consolidated statement of cash flows that were recognized in accordance with International Financial Reporting Standards (IFRS).

2. HOCHTIEF Americas

The HOCHTIEF Americas business division combines the activities of the HOCHTIEF Group's operational units mainly in the United States and Canada, where it mainly operates through its subsidiaries The Turner Corporation, Dallas/USA ("**Turner**"), Flatiron Holding Inc., Delaware/USA ("**Flatiron**"), E.E. Cruz & Company Inc., New Jersey/USA and the Canadian construction company Clark Builders (consisting of Clark Builders Partnership, Edmonton/Canada, CB Resources Corporation, Edmonton/Canada and CB Finco Corporation, Edmonton/Canada), in which the HOCHTIEF Group, through its subsidiary Turner, holds a majority interest of 51 per cent.

Turner is active in the building construction sector and has established itself as the number 1 general builder in the US market based on sales (*source*: ENR Source Book, September 2013). Within its network of offices located in or near most major cities throughout the United States, Canada and Mexico as well as in selected international locations, Turner operates business units which are focused on Turner's key market sub-segments Healthcare, Education/Science, Public/Justice, Commercial/Retail, Transportation, Sports/Entertainment, and Pharmaceutical/Manufacturing facilities. Within these market sub-segments, Turner offers pre-construction consulting, program management, project management, construction management, design/build, general contracting and facility management services. Turner is the US market leader in the segments education, commercial offices, sports, hotels, motels and convention centres, entertainment/casinos, health care, and cultural facilities based on sales (*source*: McGraw-Hill, ENR Source book, September 2013). It is also the number one in the green building market (*source*: McGrawHill, ENR magazine. The Top 100 Green Contractors, September 2013). Turner was also recognized top contractor in the United States in the industry for the utilization of Building Information Modeling tools on projects (*source*: Building Design & Construction, July 2013).

The civil engineering company Flatiron is one of the top US companies in complex infrastructure construction and civil engineering projects, including the seventh place in highways and the sixth place in bridges (*source*: ENR Source book, September 2013) and has operations in both the USA and Canada, giving the HOCHTIEF Group a presence in North America as a transportation and energy infrastructure provider as well. Flatiron offers a full range of construction and engineering services through various types of contracts such as design-build, construction management/general contractor (CM/GC), and public-private partnerships (also in cooperation with HOCHTIEF PPP Solutions North America Inc. and HOCHTIEF Solutions AG) and operates from regional and project offices in many regions of the United States and Canada. Through Flatiron, the HOCHTIEF Group entered the growing market for US infrastructure projects on a public-private partnership basis.

3. HOCHTIEF Asia Pacific

The HOCHTIEF Asia Pacific business division encompasses the HOCHTIEF Group's activities in the Asia-Pacific region through its fully consolidated majority shareholding of approximately 58.7 per cent. (as of 31 March 2014) in Leighton Holdings Limited (together with its subsidiaries and affiliates, the "**Leighton Group**"). In the course of further enhancing its shareholding in Leighton Holdings Limited, the Issuer launched a proportional takeover bid, offering to the shareholders of Leighton Holdings Limited to purchase further shares. The offer expired on 9 May 2014. After completion of the purchase in the course of which HOCHTIEF Group invested approximately EUR 574 million, the Issuer holds 69.62 per cent. of the total outstanding share capital in Leighton Holdings Limited as of 9 May 2014. The remaining shares are broadly held.

Leighton Holdings Limited is the publicly listed parent company of the Leighton Group, focusing on strategic and financial management, market positioning and corporate and public affairs of the Leighton Group.

The Leighton Group focuses mainly on the infrastructure and resources segment, which includes construction, contract mining, operation and maintenance, and services in the segment. The Leighton Group's business is conducted through six independent key operating companies in more than 20 countries from headquarters in Australia, Hong Kong and Dubai. The Leighton's Group six independent key operating units comprise Thiess (together with its subsidiaries and affiliates, "**Thiess**"), Leighton Contractors (together with its subsidiaries and affiliates, "**Leighton Contractors**"), John Holland Group (together with its subsidiaries and affiliates, "**John Holland**"), Commercial & Residential, consisting of Leighton Properties and Devine (together with its subsidiaries and affiliates, "**Commercial & Residential**"), the Habtoor Leighton Group ("**HLG**") in which Leighton Africa Limited holds a minority stake and Leighton Asia, India & Offshore consisting of Leighton Asia, Leighton India (in which the Leighton Asia, India & Offshore Group holds a 100 per cent. stake) and Leighton Offshore (together with its subsidiaries and affiliates, "**Leighton Asia, India & Offshore**"). The Leighton Group has a strong market position in the Australian home market and in Asian core markets, especially in Hong Kong, Indonesia and the United Arab Emirates.

Thiess offers integrated engineering and construction services as well as contract mining and services throughout Australia, Indonesia, India and New Zealand. Its main activities include contract mining, civil engineering, process management services, building construction, environmental services, utilities services and facilities operation and maintenance.

Leighton Contractors is a project development, construction and services contractor specialising in civil engineering, major infrastructure development, building construction, contract mining, process engineering, telecommunication services and facilities management and serves its clients across Australia and New Zealand.

John Holland is a diversified and multi-disciplined construction and services contractor operating throughout Australia with its core competencies in non-residential building construction, civil engineering construction, rail maintenance and new rail construction, telecommunications services, asset management, and heavy industry and process engineering.

The Commercial & Residential segment integrates property development companies based in Australia offering a wide range of property development services to both public and private sectors with a focus on the commercial, mixed-use, industrial, residential and resort sectors.

HLG currently operates throughout the United Arab Emirates, Qatar, Oman and Saudi Arabia. Habtoor Leighton Group, its main affiliate, is one of the leading multi-disciplined contractors in the Middle East specialising in building construction, civil engineering and infrastructure, the oil and gas sector and the rail industry.

Leighton Asia, India & Offshore operates in Hong Kong, Macau, China, Mongolia, Taiwan, Philippines, Guam, Thailand, Vietnam, Laos, Cambodia, Malaysia, Singapore, Indonesia and Brunei and is a multi-disciplined general contractor specialising in civil and infrastructure construction, contract mining as well as industrial and building construction. Leighton Asia, India & Offshore is also a multi-disciplined general contractor currently operating in India in the building and civil construction area. In addition, under the business unit Leighton Offshore, the Leighton Asia, India & Offshore operates five modern, purpose-built pipe lay and cable lay barges and has experience in both small and large diameter pipeline.

The Issuer intends to work with the Leighton Group board and management to complete the broad based, general review of Leighton's operating model that is currently being undertaken by the Leighton Group management. A particular focus of the review is whether the existing operating businesses of the Leighton Group can be more efficiently structured. The review is expected to be completed by the end of 2014. The general review will seek to identify areas which may be further improved in order to further enhance performance. Areas for further improvement may involve leveraging the capability set offered by each operating subsidiary and/or geographies in which they operate. The outcome of this review may result in changes to the structure of the operating businesses, including changes to the way in which those businesses are managed, changes in the number and functions of employees required in each operating unit and the possible divestment of certain assets or businesses.

4. HOCHTIEF Europe

The HOCHTIEF Europe division oversees the Group's business in Europe and selected growth regions around the world. Under the leadership of HOCHTIEF Solutions AG (together with its subsidiaries and affiliates referred to as "**HOCHTIEF Solutions**"), the HOCHTIEF Europe division focuses on infrastructure construction projects.

Core capabilities include building construction together with civil and structural engineering. The division also undertakes concessions and operation projects on a public-private partnership basis.

HOCHTIEF Solutions consolidates the core business of the HOCHTIEF Group in Europe and in selected regions worldwide. The company plans, develops, builds, operates and manages real estate and infrastructure facilities. HOCHTIEF Solutions is the management company of the HOCHTIEF Group's Europe division.

Under its new structure as of 1 January 2014, HOCHTIEF Europe decentralized the operating activities within HOCHTIEF Group. HOCHTIEF Solutions now has in total four business lines: Infrastructure Solutions, Building Solutions, Engineering Solutions and PPP Solutions. The former Real Estate Solutions business line is no longer classified as core business, but, for the time being, remains a part of the HOCHTIEF Europe division.

HOCHTIEF Infrastructure implements traffic and energy infrastructure projects in Europe and selected regions around the world. The HOCHTIEF Solutions subsidiary covers a broad range from bridges, roads, tunnels, ports, railways, airports and urban infrastructure to facilities for generating conventional and renewable energy, such as offshore wind turbines. It offers services for all phases in the implementation of a project and is able to satisfy a wide range of project requirements in terms of location, size and engineering solutions. In addition to strong local sites in Germany and various European countries, it also holds regional units in the Middle East, South Africa and Latin America.

HOCHTIEF Building bundles the traditional construction business of the HOCHTIEF Group in Germany. Working in cooperation with customers and partners, the eight branches of this subsidiary of HOCHTIEF Solutions offer solutions for all aspects of turnkey construction and structural work.

HOCHTIEF Engineering is a construction engineering firm based in Germany with more than 500 employees worldwide. This subsidiary of HOCHTIEF Solutions creates solutions in the business areas of building, energy and transport infrastructure with project-based services such as consulting, planning, engineering, planning and project management, building information modeling and technology development.

HOCHTIEF PPP Solutions develops and implements concessions and operator projects in the business areas of roads and social infrastructure. Its experts have also been working in the field of energy since 2007. In the field of public-private partnerships, HOCHTIEF PPP Solutions provides services and solutions to the public partners of HOCHTIEF Group. HOCHTIEF PPP Solutions has business units and offices in Germany, The Netherlands, the United Kingdom, Chile, Greece, Canada and the US and is currently involved in 36 public-private partnership projects (26 social infrastructure projects and 10 transport infrastructure projects).

In the former Real Estate Solutions business line, HOCHTIEF Solutions manages real estate projects, providing services ranging from comprehensive analyses of the market and location, acquisition of land to marketing, financing, implementation of real estate projects. The business line is predominantly active in Germany and in selected Western and Central Eastern European countries including Austria, Luxembourg, Poland, Switzerland and the Czech Republic. As part of its strategy announced on 28 February 2013, the HOCHTIEF Group is weighing strategic alternatives for its subdivisions HOCHTIEF Projektentwicklung and formart, for example a sale or strategic alliances.

Furthermore, the HOCHTIEF Group is active, and considers itself as one of the leading providers, in the offshore market. In recent years, the HOCHTIEF Group assisted clients in this market to implement complex projects. Such projects extend beyond the German coast and

include other target markets such as the UK. Since January 2013, HOCHTIEF is also active in the oil and gas markets.

5. Market and Competition

The HOCHTIEF Group is the second most internationalized construction service provider of the world (*source*: ENR TOP 250 International Contractors, August 2013) and is active in major geographical markets, notably Europe, North America, Australia, the Asia-Pacific region and the Gulf States. For the fiscal year ended 31 December 2013, the largest markets of the HOCHTIEF Group were Americas (primarily North America, 30 per cent. of the HOCHTIEF Group's sales in the fiscal year ended 31 December 2013), Australia (49 per cent. of the HOCHTIEF Group's sales in the fiscal year ended 31 December 2013), Germany (7 per cent. of the HOCHTIEF Group's sales in the fiscal year ended 31 December 2013) and Asia (11 per cent. of the HOCHTIEF Group's sales in the fiscal year ended 31 December 2013) (all based on sales figures restated due to the first time application of IFRS 11). In these markets the HOCHTIEF Group focuses on infrastructure construction which is its core business.

Demand for construction services is generally sensitive to the development of the macroeconomic environment. Real estate markets are predominantly influenced by demographics, consumer confidence and general prosperity whereas public non-residential construction and infrastructure are significantly influenced by government spending policies and current political priorities. The ongoing international financial and economic crisis therefore has a distinct impact on the real estate and construction markets overall. The market for energy infrastructure is influenced by political decisions, notably the initiated change from nuclear and fossil to renewable energy in Germany. However, the influence of the macroeconomic environment may vary considerably by market segment within a country or region and by market segments overall and different market segments and/or regions may move in different cycles. The HOCHTIEF Group sees itself in a good position to compensate regional market fluctuations due to its worldwide presence and broad industry diversification.

The markets in which the HOCHTIEF Group operates are subject to significant competition. The HOCHTIEF Group competes in these markets with large international competitors as well as with companies with predominantly regional activities. Some of the markets in which the HOCHTIEF Group operates are highly fragmented by region and by market segment. As a consequence, a major competitor in one region or market segment may not be necessarily a competitor in another region or market segment.

6. Investments

In the HOCHTIEF Asia Pacific division, the Issuer has increased its fully consolidated majority shareholding in Leighton Holdings Limited from 58.7 per cent. (as of 31 March 2014) to 69.62 per cent. as of 9 May 2014, an investment of approximately EUR 574 million. Further principal investments were not completed since 31 December 2013. Future investments on which firm commitments have already been made amount to EUR 125.3 million over the next years to be paid as capital contributions in connection with public-private partnership projects of HOCHTIEF PPP Solutions in the HOCHTIEF Europe division (as of 31 March 2014). Investments will either be financed from operating cash flows or by using external financing.

7. Material Contracts

Other than the financing contracts described above (see "*INFORMATION ABOUT THE ISSUER – Financing Structure of the HOCHTIEF Group*"), the Issuer has not entered into material contracts in the ordinary course of its business, which could result in any group member being under an obligation or entitlement that is material to the issuer's ability to meet its obligation to the Holders.

8. Recent Developments/Trend Information

There has been no material adverse change in the prospects of the Issuer since 31 December 2013.

There have been no significant changes in the financial or trading position of the Issuer since 31 March 2014.

9. Legal and Arbitration Proceedings

Companies of the HOCHTIEF Group are subject to a variety of claims and lawsuits that arise from time to time in the ordinary course of their business, including proceedings and claims that relate to companies which HOCHTIEF has acquired, and claims that relate to customers demanding indemnification for proceedings initiated against them.

In particular, during the previous 12 months the Issuer was involved in the following governmental, legal or arbitration proceedings which may have, or have had in the recent past, significant effects on the Issuer and/or HOCHTIEF Group's financial position or profitability.

In September 2011, an arbitration proceeding was initiated against certain companies of the HOCHTIEF Group in connection with its indirect holding in the Budapest Airport. The claim is based on the allegation that a change of control in the Issuer occurred that entitles the claimant under a shareholder's agreement to sell its respective indirect holding in the Budapest Airport to HOCHTIEF AirPort at market value to be calculated using predefined valuation methods. Although the HOCHTIEF Group sold its airport business with economic effect of 1 January 2013, the HOCHTIEF Group still bears the economic risk with regard to the arbitration proceeding which is still pending at the date of this Prospectus and the HOCHTIEF Group vigorously defends itself against the claims raised and intends to do so in the future. There is a risk of individual or other co-shareholders in Budapest Airport consortium filing for arbitration correspondingly.

In connection with construction work for a hydroelectric power plant in Fort Augustus, Scotland, HOCHTIEF Solutions AG and HOCHTIEF (UK) Construction Limited were sued in July 2011 by SSE Generation Limited. SSE Generation Limited sought damages in an amount of up to GBP 170 million for the partial collapse of a water tunnel and the subsequent shutdown of the power plant. HOCHTIEF Solutions AG and HOCHTIEF (UK) Construction Limited initiated adjudication proceedings on the same dispute under the Housing Grants Construction and Regeneration Act, 1996. In late 2011, the adjudicator confirmed that HOCHTIEF Solutions AG and HOCHTIEF (UK) Construction Limited were not responsible for the collapse, and consequently no moneys were due by either HOCHTIEF Solutions AG or HOCHTIEF (UK). Nevertheless, SSE Generation Limited challenged the adjudication decision and in late 2012 recommenced legal proceedings, presently claiming approximately GBP 133 million plus interest. The lawsuit is currently pending before the Court of Sessions in Edinburgh. The HOCHTIEF Group currently intends to vigorously defend itself against the claims raised.

In connection with a contract for the transport and installation of tripod foundations and wind energy converters for an offshore wind farm in the German North Sea, HOCHTIEF Infrastructure GmbH referred numerous claims (clustered in packages) to a Dispute Adjudication Board (**DAB**). The first package mainly concerned delays in connection with the provision of tripods and amounted to EUR 20.27 million. The employer disputed the basis of the claims, in particular the amounts of the claims, and raised a counter-claim for liquidated damages in the amount of EUR 18.6 million. The DAB held that HOCHTIEF's claims are justified at an amount of EUR 8.44 million. However, the DAB also fully upheld the employer's claim for liquidated damages (EUR 18.6 million). HOCHTIEF intends to bring out a notice of dissatisfaction. Whether the case will be referred to an arbitral tribunal has not been decided yet. The second package is based on the employer's postponement of the installation of the wind energy converters and has a volume of EUR 46.36 million. The employer disputes mainly the amount of the claim. The DAB scheduled the oral hearing for mid-June 2014. HOCHTIEF Infrastructure GmbH intends to refer further claims based on disruptions and instructed variations to the DAB totaling to approximately EUR 50 to 60 million.

In connection with a project in Qatar, negotiations for the final account are still ongoing. HOCHTIEF Infrastructure GmbH is claiming QAR 7,920 million (EUR 1,573 million). The employer has offered QAR 7,150 million (EUR 1,420 million), which is falling short of HOCHTIEF's expectations. The next settlement meeting will take place in May 2014. A standing Dispute Adjudication Board is in place.

Furthermore, there is an investigation with regard to potential anti-competitive behaviour of Leighton Offshore Pte. Limited in connection with work to expand offshore loading facilities for Iraq's crude oil exports. The investigation, which was initiated by a report of Leighton

Holdings Limited to the Australian Federal Police, is still ongoing at the date of this Prospectus and the HOCHTIEF Group intends to fully cooperate with the Australian Federal Police.

The HOCHTIEF Group will continue to vigorously defend itself against all claims and lawsuits against it, unless otherwise described above. The Issuer records provisions for such matters when it is probable that it has a present obligation that results from a past event, is reliably estimable and the settlement of which is probable to require an outflow of resources embodying economic benefits. Other than as described above, the Issuer currently believes that all claims and lawsuits against it (including any pending or threatened litigation), individually or in aggregate, did not and will not have a material adverse effect on the HOCHTIEF Group's business, financial position, income, or cash flows. Consequently, the provisions currently recorded for these claims and lawsuits are neither individually nor in aggregate material to the HOCHTIEF Group.

However, all claims and lawsuits involve risk and could lead to significant financial and reputational damage to the parties involved. Because of significant inherent uncertainties related to these matters, there can be no assurance that the HOCHTIEF Group's business, financial position, income or cash flows will not be materially adversely affected nor can the maximum possible loss in case of an unfavourable outcome be reliably estimated.

VI. Administrative, Management and Supervisory Bodies

In accordance with the German Stock Corporation Act (*Aktiengesetz*), the Issuer has both an executive board (*Vorstand*) (the "**Executive Board**") and a supervisory board (*Aufsichtsrat*) (the "**Supervisory Board**"). The Executive Board is responsible for the management of the HOCHTIEF Group's business; the Supervisory Board supervises the Executive Board and appoints its members. The two boards are separate, and no individual may simultaneously be a member of both boards.

Executive Board

As at the date of this Prospectus, the current members of the Executive Board, their areas of responsibility and their positions outside of the Issuer are as set out in the following table. José Ignacio Legorburo Escobar and Nikolaus Graf von Matuschka have been appointed as additional members of the Executive Board on 7 May 2014. As at the date of this Prospectus, the allocation of duties has not yet been finalized amongst the four members of the Executive Board.

Conflicts of Interest

As of the date of this Prospectus, the above mentioned members of the Executive Board and the Supervisory Board of the Issuer do not have potential conflicts of interests between any duties to the Issuer and their private interests or other duties.

Board Practice

The governing bodies of the Issuer are the Executive Board (*Vorstand*), the Supervisory Board (*Aufsichtsrat*) and the General Shareholders' Meeting (*Hauptversammlung*). The powers of these bodies are set forth in the German Stock Corporation Act, the Issuer's articles of association and the rules of procedure of the Executive Board and the Supervisory Board and its committees. The Executive Board and Supervisory Board work independently of each other. No person may serve on both boards at the same time.

The Executive Board is responsible for managing the HOCHTIEF Group's day-to-day business and for representing the Issuer in dealings with third parties. The Supervisory Board appoints and may dismiss members of the Executive Board. The Supervisory Board supervises and advises the Executive Board in its management of HOCHTIEF and represents the Issuer in transactions between a member of the Executive Board and the Issuer. In general, the Supervisory Board is not directly involved in the day-to-day management of the HOCHTIEF Group.

In performing their duties, members of both the Executive Board and Supervisory Board must exercise the duties of care expected of a reasonable business person. Members of the Executive Board and the Supervisory Board must consider a broad range of interests, including those of the Issuer and its shareholders and employees.

The members of the Executive Board and the Supervisory Board may be held personally liable to the Issuer for breaches of their duties of loyalty and care. The Issuer must bring an action for breach of duty against members of the Executive Board or Supervisory Board upon a resolution of the stockholders passed at a stockholders' meeting by a simple majority of votes cast. Furthermore, minority shareholders representing at least 1 per cent. of the Issuer's share capital or shares with a nominal value of EUR 100,000 can be admitted by the competent court to assert claims for damage of the Issuer against members of either of the Issuer's boards in their own name.

With the exception of stockholders of companies that are under the control of another company, individual stockholders of German companies cannot sue directors on behalf of the company. Under German law, directors may be liable to a breach of duty to stockholders (as opposed to a duty to the company itself) only where a breach of duty to the company also constitutes a breach of a statutory provision enacted specifically for the protection of stockholders. As a practical matter, stockholders are able to assert liability against directors for breaches of this sort only in unusual circumstances. The German Securities Trading Act (*Wertpapierhandelsgesetz*) provides for damage claims of stockholders against the Issuer under certain circumstances, if the Issuer violates the provisions on publication of insider information with intent or gross negligence.

Executive Board

The Executive Board draws up bylaws. The Executive Board conducts the business of the company by common responsibility shared among all its members. The Executive Board determines entrepreneurial goals, the fundamental strategic direction, corporate policy and the HOCHTIEF Group's organisation. The Executive Board makes all decisions in the form of resolutions. Major decisions of the Executive Board require Supervisory Board approval.

The Executive Board provides the Supervisory Board with regular written and verbal reports containing full and timely information on the financial position and development of both the Issuer and the HOCHTIEF Group, significant transactions and the current results of operations, including information on the risk position and risk management. In the final session of the financial year, the Executive Board also submits to the Supervisory Board planning for the HOCHTIEF Group's investments, finance and personnel for the coming financial year, as well as medium-term planning. A person may not serve on the Executive Board and on the Supervisory Board at the same time.

Outside of its meetings, the Supervisory Board is kept fully abreast by the Executive Board of particularly significant or urgent projects and events. The chairman of the Supervisory Board also maintains regular contact with the Executive Board outside of meetings and keeps himself informed of the current status of the business and key transactions. Any business or initiatives that require the consent of the Supervisory Board are submitted to that body in a timely fashion.

Pursuant to the articles of association, the Executive Board must consist of at least 2 members. Currently, the Issuer's Executive Board is composed of 2 members. Any 2 members of the Executive Board jointly or one member of the Executive Board and a holder of a special power of attorney (*Prokurist*) jointly may legally represent the Issuer. The Supervisory Board appoints each member of the Executive Board for a maximum term of 5 years, with the possibility of re-appointment. Under certain circumstances, a member of the Executive Board may be removed by the Supervisory Board prior to the expiration of that member's term. A member of the Executive Board may not vote on matters relating to certain contractual agreements between such member and the Issuer, and may be liable to the Issuer if such member has a material interest in any contractual agreement between the Issuer and a third party which was not disclosed to and approved by the Supervisory Board. Further, as the compensation of the Executive Board members is set by the Supervisory Board, Executive Board members are unable to vote on their own compensation.

Under German law the Issuer's Supervisory Board members and Executive Board members have a duty of loyalty and care towards the Issuer. They must exercise the standard of care of a prudent and diligent businessman and bear the burden of proving they did so if their actions are contested. Both bodies must consider the interest of the Issuer's shareholders and the employees and, to some extent, the common interest. Those who violate their duties

may be held jointly and severally liable for any resulting damages, unless they acted pursuant to a lawful resolution of the annual General Shareholders' Meeting.

The Issuer has implemented a Code of Conduct for employees covering the following topics: conflict of interest, bribery and corruption, observance of anti-trust rules, donations and sponsoring, insider rules, dealing with internal knowledge, confidentiality, data protection, documentation of business transactions, treatment of company property and assets, respecting human dignity, rejection of child labour and forced labour, equality of opportunity and the prohibition of discrimination, health and safety, environmental protection and the right of association and of collective bargaining. The Code of Conduct is equally applicable to managers and members of the Executive Board.

Supervisory Board

The Supervisory Board oversees and advises the Executive Board in heading up the corporation's business. The Supervisory Board is involved in all decisions of fundamental importance to the company. At regular intervals the Supervisory Board discusses business development and planning, strategy and implementation. The Supervisory Board approves the consolidated financial statements of the Issuer, with due consideration for auditing reports from the certified public accountants performing the final audit and the outcome of audits performed by the audit committee.

The Supervisory Board makes decisions by resolution.

When the Supervisory Board votes, the chairman has the casting vote, according to the rules of the German Co-determination Act of 1976 (*Mitbestimmungsgesetz*), if a second round of voting also ends in a draw.

The German Co-determination Act of 1976 requires supervisory boards of corporations with more than 2,000 employees to consist of an equal number of representatives of the shareholders and representatives of the employees. The minimum total number of supervisory board members, and thus the minimum number of shareholder representatives and employee representatives, is legally fixed and depends on the number of employees employed by the corporation and its German subsidiaries. The Supervisory Board has to consist of 16 members, of which 8 members have to be elected by the Issuer's shareholders at the annual General Shareholders' Meeting and 8 members have to be elected by the employees of the German HOCHTIEF entities (i.e. entities of the HOCHTIEF Group having their registered office in Germany).

Any Supervisory Board member elected by the shareholders at the annual General Shareholders' Meeting may be removed by a simple majority of the votes cast at the annual General Shareholders' Meeting. Any Supervisory Board member elected by the employees may be removed by three quarters of the votes cast by the employees of companies of the HOCHTIEF Group having their registered office in Germany.

The Supervisory Board elects a chairperson and a deputy chairperson among its members by a majority of two-thirds of the votes of its members. If such majority is not reached on the first vote, the chairperson will be chosen solely by the members elected by the shareholders and the deputy chairperson will be chosen solely by the members elected by the employees. Unless otherwise provided by law, the Supervisory Board acts by simple majority. In the case of any deadlock the chairperson has the deciding vote.

The members of the Supervisory Board cannot be elected for a longer term than approximately 5 years. The members of the Supervisory Board shall hold office until the end of the annual General Shareholders' Meeting at which they are discharged from responsibility for the fourth financial year after commencement of their period of office, not counting the financial year in which their period of office commenced. The Supervisory Board normally meets four times a year. The remuneration of the members of the Supervisory Board is determined by the articles of association.

As stipulated in the German Corporate Governance Code, an adequate number of the Supervisory Board members are independent. To be considered for appointment to the Supervisory Board and for as long as they serve, members must comply with certain criteria concerning independence, conflicts of interest and multiple memberships of management, supervisory and other governing bodies. They must be loyal to the Issuer in their conduct and shall not exercise directorships or similar positions for important competitors of the Issuer. Members are subject to insider trading prohibition and the respective directors' dealing rules of the German Securities Trading Act. A member of the Supervisory Board may not vote on matters relating to certain contractual agreements between such members and the Issuer. Further, as the compensation of the Supervisory Board members is laid down in the articles of association, Supervisory Board members are unable to vote on their own compensation.

The Supervisory Board may appoint committees from among its members and may, to the extent permitted by law, entrust such committees with the authority to make decisions. Currently the Supervisory Board maintains the following committees:

The audit committee within the meaning of section 107 (3) sentence 2 AktG ("**Audit Committee**") deals in particular with issues relating to the monitoring of the accounting process, the effectiveness of the internal control system and the internal audit system, the audit of the Annual Financial Statements and – unless another committee is entrusted therewith – compliance. Half-year and quarterly financial reports are discussed by the Audit Committee together with the Executive Board prior to publication unless these reports are discussed by the Supervisory Board. The chairman of the Audit Committee must have specialist knowledge and experience in the application of accounting principles and internal controlling procedures. He must not be any former member of the Executive Board of the Issuer whose term of office ended less than two years previously. The Audit Committee consists of three Supervisory Board shareholder representatives and three Supervisory Board employee representatives respectively. The Audit Committee is currently composed of six members: Ángel García Altozano (Chairman), Gregor Asshoff (Deputy Chairman), José Luis del Valle Pérez, Matthias Maurer, Nikolaos Paraskevopoulos and Dr. Jan Martin Wicke.

Other committees are the executive committee, the mediation committee, the human resources committee, the nomination committee and the strategy committee. The executive committee prepares the Supervisory Board meetings and the Supervisory Board decisions on matters requiring the approval of the Supervisory Board. In addition, the executive committee is notified on a regular basis by the Executive Board about significant business occurrences. The mediation committee is an obligatory committee in line with section 27 (3) of the Co-determination Act (MitbestG). The human resources committee prepares the personnel decisions for the Supervisory Board. The nomination committee is responsible for suggesting suitable candidates to the Supervisory Board for its proposals to the General Shareholders' Meeting for the election of the members of the Supervisory Board. The strategy committee discusses strategy and corporate development and prepares resolutions on strategic concerns by the Supervisory Board.

The duties, procedures and committees of the Supervisory Board are specified in their respective bylaws which reflect the requirements of the German Stock Corporation Act and the German Corporate Governance Code. The committee chairs report regularly to the Supervisory Board concerning the work of their committees.

German Corporate Governance Code

In February 2014, the Executive Board and Supervisory Board of the Issuer approved and issued a declaration of compliance (*Entsprechenserklärung*) pursuant to Section 161 of the German Stock Corporation Act (*Aktiengesetz*) stating the following:

“After due appraisal, the Executive Board and Supervisory Board of HOCHTIEF Aktiengesellschaft submit their compliance declaration as follows:

In the period since submission of the last compliance declaration in February 2013 up to June 10, 2013, HOCHTIEF Aktiengesellschaft, with the following exceptions, complied with all recommendations of the Government Commission on the German Corporate Governance Code dated May 15, 2012 and published on June 15, 2012 by the German Ministry of Justice in the official section of the Bundesanzeiger (Federal Official Gazette).

Since June 11, 2013 HOCHTIEF Aktiengesellschaft has complied with the recommendations of the Code published on June 10, 2013, also with the following exceptions:

- Since 2012, Section 5.3.2, last sentence, of the Code has contained a recommendation that the Chairman of the Audit Committee should be independent. To comply with this recommendation, the Supervisory Board would have had to vote out of office the current Chairman of the Audit Committee, Mr. Ángel García Altozano. The Supervisory Board is of the opinion that it is in the interests of the Company for Mr. García Altozano to remain Chairman of the Audit Committee despite his business relations with ACS, Actividades de Construcción y Servicios, S.A. This assessment is based on the fact that Mr. García Altozano has been a member of the Audit Committee since 2007 and its Chairman since May 2010. In its decision, the Supervisory Board took into account Mr. García Altozano's considerable expertise and experience from having held leading positions in international companies.
- The Supervisory Board has determined that it includes what it considers to be an adequate number of independent members within the meaning of Section 5.4.2 of the Code. In departure from Section 5.4.1 paragraphs 2 and 3 of the Code however, it did not take into account the number of independent Supervisory Board members within the meaning of Section 5.4.2 when specifying concrete objectives regarding its

composition. The Supervisory Board has furthermore specified objectives which, while considering the specifics of the enterprise, take into account the international activities of the enterprise, potential conflicts of interest, the age limit specified by the Supervisory Board for its members, and diversity. In view of residual uncertainty regarding the required level of concreteness of the objectives to be specified, in order to avoid the risk of resolutions being challenged on this basis in court, a departure from Section 5.4.1 paragraphs 2 and 3 is therefore declared as a precautionary measure. The Supervisory Board will continue to comply with the statutory requirements in its election recommendations to the General Shareholders' Meeting, placing the priority on the professional and personal qualification of candidates. It goes without saying in this connection that allowance will also be made for the international activities of the enterprise, potential conflicts of interest, the number of independent Supervisory Board members, an age limit for Supervisory Board members, and diversity.

- The Code's recommendations on election recommendations to the General Shareholders' Meeting contained in Section 5.4.1 paragraphs 4 to 6 of the Code (disclosure of the personal and business relations of each individual candidate with the enterprise, the executive bodies of the Company and with any shareholder holding a material interest in the Company) are not applied. In practice, there is currently still legal uncertainty regarding the nature and scope of the circumstances to be disclosed in election recommendations. It is therefore to be feared that the specificity problem with this new Code recommendation may be used to challenge resolutions in court. The Supervisory Board will watch developments in this regard and re-examine the question of applying the new Code recommendations in the next fiscal year.
- Section 5.4.6 paragraph 2, second sentence, of the Code provides that any profit-based compensation for members of the Supervisory Board must be oriented toward sustainable growth of the enterprise. The terminological resemblance between this wording and the provisions of the German Stock Corporations Act on Executive Board compensation suggests that the Code requires a multi-year assessment basis for profit-based Supervisory Board compensation in the same way as the Stock Corporations Act requires for Executive Board compensation. Under Article 18, paragraphs 1 and 2 of the Articles of Association of HOCHTIEF Aktiengesellschaft, members of the Supervisory Board receive profit-based compensation alongside their fixed compensation. The profit-based compensation consists of a bonus based on the annual dividend. However, in departure from the aforesaid interpretation of Section 5.4.6 paragraph 2, second sentence, of the Code, no use is made, in the Articles of Association, of a multi-year assessment basis. The composition of compensation for Supervisory Board members laid down in the Articles of Association was adopted by resolution of the General Shareholders' Meeting in June 2003 and complied with the German Corporate Governance Code until the amendments came into force in June 2012. In the current fiscal year, the Executive Board and the Supervisory Board will once again review whether a corresponding amendment and revision in line with the modified Code recommendation should be proposed to the General Shareholders' Meeting.

With regard to the recommendation given in Section 4.2.3, second paragraph, sixth sentence of the Code (as amended in June 2013)—that the amount of compensation be capped, both overall and for variable compensation components—we note that the contracts with the members of our Executive Board, as well as providing for a fixed salary, include caps on the amounts of all variable compensation elements. Supplementary to this, the Supervisory Board has reserved the right, in addition to the fixed annual salary and the variable compensation components, to grant a one-off payment for exceptional performance. The contracts also provide for normal fringe benefits (private use of company car, accident insurance, etc.). There is no cap on the amount of any one-off payment for exceptional performance or on the value of fringe benefits because it does not appear necessary for such amounts to be capped in accordance with the letter and spirit of the Code recommendation and, in our legal appraisal, the Code recommendation does not extend to this. For the same reason, such payments and benefits are not covered by any cap on the amount of overall compensation.”

VIII. Outlook

HOCHTIEF Group will continue to focus on its strategy to structurally improve profitability and cash performance in 2014. For HOCHTIEF Americas, including the international group companies Turner and Flatiron, the Issuer expects that operational earnings will be higher than in the prior year. Looking to the Leighton Group, firm operational earnings performance in local currency terms is expected, despite a challenging environment. Regarding the HOCHTIEF Europe division, the Issuer expects a significant improvement in operational earnings as a result of the fundamental repositioning and streamlining of the business. In terms of the Group, in 2014 it is expected to achieve further progress with an operating consolidated net profit slightly above 2013 figures. The Issuer anticipates that this will be achieved with improved profit margins in all divisions. Focus on cash continues. Thus, the further strengthening of the balance sheet and the target to approach a net cash position by year end. The HOCHTIEF Group's new orders and work done are likely to normalize at a lower level in 2014, due partly to exchange rate effects, but it is expected to end the year with an order backlog close to the high levels of December 2013. The strong presence in American and Asia-Pacific markets means that the HOCHTIEF Group's projected earnings may be impacted by exchange rate trends. The planning is based on the assumption that there will not be a sharp slowdown in the global economy, an escalation of the financial and debt crisis, or any action on the part of individual governments that impacts significantly on HOCHTIEF Group's business.

CONDITIONS OF ISSUE

§ 1

CURRENCY, PRINCIPAL AMOUNT, FORM, CERTAIN DEFINITIONS

(1) *Currency; Principal Amount.* The issue by HOCHTIEF Aktiengesellschaft (the "**Issuer**") issued on 28 May 2014 (the "**Issue Date**") in the aggregate principal amount of EUR [●] (the "**Aggregate Principal Amount**") is divided into [●] notes in the principal amount of EUR 1,000 each payable to bearer (the "**Notes**").

(2) *Form.* The Notes are being issued in bearer form.

(3) *Global Notes.*

(a) The Notes are initially represented by a temporary global note (the "**Temporary Global Note**") without coupons. The Temporary Global Note will be exchangeable for a permanent global note (the "**Permanent Global Note**", the Temporary Global Note and the Permanent Global Note, each a "**Global Note**" and, together, the "**Global Notes**") without coupons. The Temporary Global Note and the Permanent Global Note shall each be signed by two authorised signatories of the Issuer and shall bear a control signature of the Principal Paying Agent. Definitive Notes and interest coupons will not be issued.

(b) The Temporary Global Note shall be exchanged for the Permanent Global Note on a date which will not be earlier than 40 days after the date of issue. Such exchange shall only be made upon delivery of certifications to the Issuer or any Paying Agent on the Issuer's behalf to the effect that the beneficial owner or owners of the Notes represented by the Temporary Global Note is not a U.S. person (other than certain financial institutions or certain persons holding Notes

§ 2 STATUS, NEGATIVE PLEDGE

(1) *Status.* The Notes constitute unsecured and unsubordinated obligations of the Issuer ranking *pari passu* among themselves and *pari passu* with all other unsecured and unsubordinated obligations of the Issuer, unless such obligations are accorded priority under mandatory provisions of statutory law.

"Material Subsidiary" means each fully consolidated Subsidiary of the Issuer whose unconsolidated revenues or unconsolidated assets at the end of any of the fiscal years following the Issue Date are equal to or exceed 5 per cent. of the consolidated revenues or consolidated assets, respectively, of the Group, in each case as disclosed in the audited consolidated annual financial statements of the Issuer for the respective fiscal year. § 3 INTEREST

(1) *Rate of Interest and Interest Payment Dates.* The Notes shall bear interest on their aggregate principal amount at the rate of [**●**] per cent. *per annum* from (and including) 28 May 2014 (the "**Interest Commencement Date**") to (but excluding) the Maturity Date (as defined in § 5 subsection 1). (3) *Calculation of Interest for Partial Periods.* Where interest is to be calculated in respect of a period which is shorter than or equal to an Interest Period, the interest will be calculated on the basis of the actual number of days elapsed in the relevant period, from and including the first date in the relevant period to but excluding the last date of the relevant period, divided by the actual number of days in the Interest Period in which the relevant period falls (including the first such day but excluding the last).

"**Interest Period**" means each period from and including the Interest Commencement Date to but excluding the first Interest Payment Date and thereafter from and including each Interest Payment Date to but excluding the next following Interest Payment Date.

§ 4 PAYMENTS

(1) *Payment of Principal and Interest.* Payment of principal and interest in respect of Notes shall be made to the Clearing System or to its order for credit to the accounts of the relevant account holders of the Clearing System.

Payment of interest on Notes represented by the Temporary Global Note shall only be made upon due certification as provided in § 1(3)(b).

Interest shall not be paid to an account within or mailed to an address within the United States (as defined in § 7(2)).

(2) *Manner of Payment.* Subject to applicable fiscal

(3) *Discharge.* The Issuer shall be discharged by payment to, or to the order of, the Clearing System.

(4) *Payment Business Day.* If the date for payment of any amount in respect of any Note is not a Payment Business Day then the Holder shall not be entitled to payment until the next Payment Business Day and shall not be entitled to further interest or other payment in respect of such delay.

For these purposes, "**Payment Business Day**" means any day which is a day (other than a Saturday or a Sunday) on which the Clearing System as well as all relevant parts of the Trans-European Automated Real-time Gross Settlement Express Transfer System (TARGET2) are operational to forward the relevant payment.

(a) Promptly upon the Issuer becoming aware that a Change of Control pursuant to § 5 subsection 3 or a failure to comply with the undertakings pursuant to § 5 subsection 5 (each a "**Put Event**") has occurred, the Issuer shall give notice (a "**Put Event Notice**") of the Put Event to the Holders in accordance with § 14. The Put Event Notice shall specify the circumstances giving rise to the Put Event and the procedure for exercising the put option set out in § 5 subsection 3 and § 5 subsection 5, respectively.

(b) In order to exercise such option, the Holder must submit during normal business hours at the specified office of the Principal Paying Agent a duly completed option exercise notice (the "**Exercise Notice**") in the form available from the specified office of the Principal Paying Agent within the period (the "**Put Period**") of 68 days after a Put Event Notice is published. No option so exercised may be revoked or withdrawn without the prior consent of the Issuer.

(2) *Notice.* Any notice, including any notice declaring Notes due, in accordance with subsection 1 shall be either be made (a) by means of a written declaration in the German or English language delivered by hand or registered mail to the specified office of the Principal Paying Agent together with a proof that such notifying Holder at the time of such notice is a holder of the relevant Notes by means of a statement of his Depository Bank (as defined in § 15 subsection 3) or any other appropriate manner or (b) with its Depository Bank for the notice to be delivered to the Clearing System for communication by the Clearing System to the Issuer.

§ 11 SUBSTITUTION

(1) *Substitution.* The Issuer may, without the consent of the Holders, if no payment of principal of or interest on any of the Notes is in default, at any time substitute for the Issuer any Affiliate (as defined below) of it as principal debtor in respect of all obligations arising from or in connection with this issue (the "**Substitute Debtor**") provided that:

- (a) the Substitute Debtor assumes all obligations of the Issuer in respect of the Notes;
- (b) the Substitute Debtor has obtained all necessary authorisations and may transfer to the Principal Paying Agent in the currency required and without being obligated to deduct or withhold any taxes or other duties of whatever nature levied by the country in which the Substitute Debtor or the Issuer has its domicile or tax residence, all amounts required for the fulfilment of the payment obligations arising under the Notes;
- (c) the Substitute Debtor has agreed to indemnify and hold harmless each Holder against any tax, duty, assessment or governmental charge imposed on such Holder in respect of such substitution;
- (d) the Issuer irrevocably and unconditionally guarantees in favour of each Holder the payment of all sums payable by the Substitute Debtor in respect of the Notes;

- (3) *Change of References.* In the event of any such substitution, any reference in these Conditions of Issue to the Issuer shall from then on be deemed to refer to the Substitute Debtor and any reference to the country in which the Issuer is domiciled or resident for taxation purposes shall from then on be deemed to refer to the country of domicile or residence for taxation purposes of the Substitute Debtor. Furthermore, in the event of such substitution the following shall apply:

In § 8 and § 5 subsection 2 an alternative reference to the Federal Republic of Germany shall be deemed to have been included in addition to the reference according to the preceding sentence to the country of domicile or residence for taxation purposes of the Substitute Debtor and in § 10 subsection 1 lit. (c) to (e) an alternative reference to the Issuer in its capacity as guarantor shall be deemed to have been included in addition to the reference to the Substitute Debtor.

§ 12

AMENDMENT OF THE CONDITIONS OF ISSUE, HOLDERS' REPRESENTATIVE

- (1) *Amendment of the Conditions of Issue.* In accordance with the German Act on Debt Securities from Entire Issues (*Gesetz über Schuldverschreibungen aus Gesamtemissionen* – "**SchVG**"), the Issuer may amend the Conditions of Issue if such amendments are approved by a majority resolution of the Holders. The majority resolutions of the Holders shall be binding on all Holders. The registration must be received at the address stated in the convening notice no later than the third day preceding the meeting. As part of the registration, Holders must demonstrate their eligibility to participate in the vote by means of a special confirmation of a Depositary Bank in accordance with § 15(3)(i)(a) and (b) hereof in text form and by submission of a blocking instruction by the Depositary Bank stating that the relevant Notes are not transferable from and including the day such registration has been sent until and including the stated end of the meeting.

(5) *Vote without a meeting.* If resolutions of the Holders shall be made by means of a vote without a meeting the request for voting (*Aufforderung zur Stimmabgabe*) will provide for further details relating to the resolutions and the voting procedure. The subject matter of the vote as well as the proposed resolutions shall be notified to the Holders together with the request for voting. The exercise of voting rights is subject to the Holders' registration. The registration must be received at the address stated in the request for voting no later than the third day preceding the beginning of the voting period. As part of the registration, Holders must demonstrate their eligibility to participate in the vote by means of a special confirmation of a Depositary Bank in accordance with § 15(3)(i)(a) and (b) hereof in text form and by submission of a blocking instruction by the Depositary Bank stating that the relevant Notes are not transferable from and including the day such registration has been sent until and including the day the voting period ends.

(6) *Second meeting.* If it is ascertained that no quorum exists for the meeting pursuant to § 12(4) or the vote without a meeting pursuant to § 12(5), in case of a meeting the chairman (*Vorsitzender*) may convene a second meeting in accordance with section 15 paragraph 3 sentence 2 of the SchVG or in case of a vote without a meeting the scrutineer (*Abstimmungsleiter*) may convene a

(6) *Holders' Representative.* The Holders may by majority resolution appoint a common representative (the "**Holders' Representative**") to exercise the Holders' rights on behalf of each Holder. Appointment of a Holders' Representative may only be passed by a majority of not less than 75% of the votes cast if such Holders' Representative is to be authorised to consent, in accordance with § 12(2) hereof, to a material change in the substance of the Conditions of Issue.

The Holders' Representative shall have the duties and powers provided by law or granted by majority resolution of the Holders. The Holders' Representative shall comply with the instructions of the Holders. To the extent that the Holders' Representative has been authorised to assert certain rights of the Holders, the Holders shall not be entitled to assert such rights themselves, unless explicitly provided for in the relevant majority resolution. The Holders' Representative shall provide reports to the Holders on its activities. The provisions of the SchVG apply with regard to the removal and the other rights and obligations of the Holders' Representative.

(7) *Notices.* Any notices concerning this § 12 shall be made exclusively pursuant to the provisions of the SchVG.

§ 13 FURTHER ISSUES AND PURCHASES

(1) *Further Issues.* The Issuer may from time to time, without the consent of the Holders, issue further Notes having the same terms and conditions as the Notes in all respects (or in all respects except for the issue date, interest commencement date and/or issue price) so as to form a single series with the Notes.

(2) *Purchases.* The Issuer may at any time purchase Notes in the open market or otherwise and at any price. Notes purchased by the Issuer may, at the option of the Issuer, be held, resold or surrendered to the Principal Paying Agent for cancellation.

§ 14 MITTEILUNGEN

(1) *Publication.* All notices concerning the Notes shall be made (a) in the Federal Gazette (*Bundesanzeiger*) and, if legally required, in the form of media determined by law in addition thereto and (b) by means of electronic publication on the internet website of the Luxembourg Stock Exchange (www.bourse.lu). Any notice so given will be deemed to have been validly given on the third day following the date of such publication.

(2) *Notification to Clearing System.* If the rules of the Luxembourg Stock Exchange otherwise so permit, the Issuer may deliver the relevant notice to the Clearing System for communication by the Clearing System to the Holders, in lieu of publication as set forth in subsection 1 lit. (b) above; any such notice shall be deemed to have been validly given on the seventh day after the day on which the said notice was given to the Clearing System.

(3) *Form of Notice.* Notices to be given by any Holder shall be made by means of a written declaration to be delivered by hand or registered mail together with the relevant Note or Notes to the Principal Paying Agent. So long as any of the Notes are represented by a Global Note, such notice may be given by any Holder of a Note to the Principal Paying Agent through the Clearing System in such manner as the Principal Paying Agent and the Clearing System may approve for such purpose.

§ 15 APPLICABLE LAW, PLACE OF JURISDICTION AND ENFORCEMENT

(1) *Applicable Law.* The Notes, as to form and content, and all rights and obligations of the Holders and the Issuer shall be governed by German law.

(2) *Place of Jurisdiction.* Subject to any mandatory jurisdiction for specific proceedings under the SchVG, the non-exclusive place of jurisdiction for any action or other legal proceedings arising out of or in connection with the Notes, to the extent legally permissible, shall be Frankfurt am Main.

(3) *Enforcement.* Any Holder of Notes may in any proceedings against the Issuer, or to which such Holder and the Issuer are parties, protect and enforce in his own name his rights arising under such Notes on the basis of (i) a statement issued by the Depositary Bank with whom such Holder maintains a securities account in respect of the Notes (a) stating the full name and address of the Holder, (b) specifying the aggregate principal amount of Notes credited to such securities account on the date of such statement and (c) confirming that the Depositary Bank has given written notice to the Clearing System containing the information pursuant to (a) and (b), and (ii) a copy of the Global Note certified as being a true copy by a duly authorised officer of the Clearing System or a depository for the Clearing System. For purposes of the foregoing, "**Depositary Bank**" means any bank or other financial institution of recognised standing authorised to engage in

§ 16 LANGUAGE

These Conditions of Issue are written in the German language. The German text shall be controlling and binding. The English language translation is provided for convenience purposes only.

TAXATION

The following is a general description of certain tax considerations relating to the acquisition and ownership of Notes in Germany, Luxembourg, Austria and The Netherlands. It does not purport to be a complete description of all tax considerations which may be relevant to a decision to purchase Notes. The following section only provides some very general information on the possible tax treatment of the Notes. In particular, this description does not consider any specific facts or circumstances that may apply to a particular purchaser. This description is based on the laws of the Federal Republic of Germany, the Grand Duchy of Luxembourg, the Republic of Austria and the Kingdom of The Netherlands currently in force and as applied on the date of this Prospectus, which are subject to change, possibly with retroactive or retrospective effect.

PROSPECTIVE PURCHASERS OF NOTES SHOULD CONSULT THEIR TAX ADVISERS AS TO THE CONSEQUENCES, UNDER THE TAX LAWS OF THE COUNTRY IN WHICH THEY ARE RESIDENT FOR TAX PURPOSES AND UNDER THE TAX LAWS OF GERMANY, LUXEMBOURG, AUSTRIA AND THE NETHERLANDS OF ACQUIRING, HOLDING AND DISPOSING OF NOTES AND RECEIVING PAYMENTS OF PRINCIPAL, INTEREST AND OTHER AMOUNTS UNDER THE NOTES. THE INFORMATION CONTAINED WITHIN THIS SECTION IS LIMITED TO TAXATION ISSUES, AND PROSPECTIVE INVESTORS SHOULD NOT APPLY ANY INFORMATION SET OUT BELOW TO OTHER AREAS; INCLUDING (BUT NOT LIMITED TO) THE LEGALITY OF TRANSACTIONS INVOLVING THE NOTES.

Federal Republic of Germany

Withholding Tax

For German tax residents (e.g., persons whose residence, habitual abode, statutory seat or place of management is located in Germany), interest payments on the Notes are subject to withholding tax, provided that the Notes are held in custody with a German custodian, who is required to deduct the withholding tax from such interest payments (the "**Disbursing Agent**"). Disbursing Agents are German resident credit institutions, financial services institutions (including German permanent establishments of foreign institutions), securities trading companies or securities trading banks. The applicable withholding tax rate is 25% (plus 5.5% solidarity surcharge thereon and, if applicable, church tax). Individuals subject to church tax may apply in writing for church tax to be levied by way of withholding. Absent such application, individuals subject to church tax have to include their investment income in their income tax return and will then be assessed to church tax. For German credit institutions, an electronic information system for church withholding tax purposes will apply in relation to investment income received after 31 December 2014, with the effect that church tax will be collected by the Disbursing Agent by way of withholding unless the investor has filed a blocking notice (*Sperrvermerk*) with the German Federal Central Tax Office (*Bundeszentralamt für Steuern*) in which case the investor will be assessed to church tax.

The withholding tax regime should also apply to any gains from the disposition or redemption of Notes realised by private investors holding the Notes as private (and not as business) assets in custody with a Disbursing Agent. Subject to exceptions, the amount of capital gains on which the withholding tax charge is applied is generally levied on the difference between the proceeds received upon the disposition or redemption of the Notes and (after the deduction of actual expenses directly related thereto) the acquisition costs. Where custody has changed since the acquisition and the acquisition data is not allowed to be proven to the Disbursing Agent or is not provided in the form required by law, the tax at a rate of 25% (plus 5.5% solidarity surcharge and, if applicable, church tax) will be imposed on an amount equal to 30% of the proceeds from the sale or redemption of the Notes.

Accrued interest (*Stückzinsen*) received by the investor upon disposal of the Notes between two interest payment dates is considered as part of the sales proceeds thus increasing a capital gain or reducing a capital loss from the Notes. Accrued interest paid by the investor upon an acquisition of the Notes after the issue date qualifies as negative investment income either to be deducted from positive investment income generated in the same assessment period or to be carried forward to future assessment periods.

According to the German tax authorities, losses resulting from a sale where the sales proceeds do not exceed the transaction costs are treated as non-deductible for German taxation purposes. Similarly, losses resulting from a bad debt loss (*Forderungsausfall*) in the case of an Issuer default or from a waiver of a receivable (*Forderungsverzicht*) in relation to the Notes, to the extent the waiver does not qualify as a hidden contribution, are not treated as tax-deductible.

German withholding tax should generally not be levied if the investor filed a withholding tax exemption certificate (*Freistellungsauftrag*) with the Disbursing Agent, but only to the extent the annual aggregate investment income does not exceed the maximum lump sum deduction amount (*Sparer-Pauschbetrag*) shown on the withholding tax

exemption certificate. Currently, the maximum lump sum deduction amount (*Sparer-Pauschbetrag*) is EUR 801 (EUR 1,602 in the case of jointly assessed investors) for all investment income received in a given calendar year. Similarly, no withholding tax should be levied if the investor has submitted to the Disbursing Agent a certificate of non-assessment (*Nichtveranlagungs-Bescheinigung*) issued by the competent local tax office.

In the case of Notes held as business assets if (a) the investor qualifies as a German tax resident corporation, association of persons (*Personenvereinigung*) or estate of assets (*Vermögensmasse*) or (b) the Notes are attributed to a domestic business in Germany and the investor notifies this to the German Disbursing Agent in the officially required form, capital gains from the disposal, sale or redemption of the Notes should not be subject to withholding tax.

The Issuer does not assume any responsibility for the deduction of German withholding tax at the source (including solidarity surcharge and, where applicable, church tax thereon).

Private Investors

For German tax resident private investors the withholding tax is – without prejudice to certain exceptions – definitive under a special flat tax regime (*Abgeltungsteuer*). Under the flat tax regime, expenses actually incurred in connection with the investment into the Notes are not tax-deductible. Private investors can apply to have their income from the investment into the Notes assessed in accordance with the general rules on determining an individual's tax bracket if this results in a lower tax burden. Pursuant to the current view of the German tax authorities (which has recently been rejected by a fiscal court in a non-binding ruling appealed to the German Federal Fiscal Court (*Bundesfinanzhof*)), in this case expenses actually incurred can also not be deducted from the investment income, except for the aforementioned lump sum deduction. An assessment is mandatory for income from the investment into the Notes where the Notes are held in custody outside of Germany. Losses resulting from the sale or redemption of the Notes can only be off-set against other investment income. In the event that, absent sufficient positive investment income, a set-off is not possible in the assessment period in which the losses have been realised, such losses can be carried forward in order to be offset against any positive investment income generated in future assessment periods.

Business Investors

Interest payments and capital gains from the disposition or redemption of the Notes held as business assets by German tax resident business investors are generally subject to German income tax or corporate income tax (plus 5.5% solidarity surcharge thereon and, if applicable in the case of an individual holding the Notes as business assets, church tax). Any withholding tax deducted from interest payments or, if applicable, from capital gains, is – as a general rule and subject to certain requirements – creditable against the German (corporate) income tax liability, or, to the extent exceeding the (corporate) income tax liability, refundable. The interest payments and capital gains are also subject to trade tax, if the Notes are attributable to a trade or business.

Foreign Tax Residents

Investors not resident in Germany should, in essence, not be taxable in Germany with the proceeds from the investment in the Notes, and no German withholding tax should be withheld from such income, even if the Notes are held in custody with a German credit (or comparable) institution. Exceptions apply, e.g., where the Notes are held as business assets in a German permanent establishment of the investor. However, a non-resident investor may be subject to tax with any income derived from the Notes in the jurisdiction where such investor is tax resident.

Substitution of the Issuer

If the Issuer exercises the right to substitute the debtor of the Notes, the substitution might, for German tax purposes, be treated as an exchange of the Notes for new notes issued by the Substitute Debtor and subject to similar taxation rules like the Notes. In particular, such a substitution might result in the recognition of a taxable gain or loss for any Holder. The Substitute Debtor is obligated to indemnify each Holder for any tax incurred by such Holder as a result of a substitution of the Issuer (cf. "Conditions of Issue – § 11(1)(c)").

Other taxes

At present, the purchase, sale or other disposal of Notes does not give rise to capital transfer tax, value added tax, stamp duties or similar taxes or charges in Germany. However, under certain circumstances entrepreneurs may opt for a liability to value added tax with regard to the sales of Notes which would otherwise be tax exempt. Net wealth tax (*Vermögensteuer*) is, at present, not levied in Germany.

Luxembourg

The following is a general description of certain Luxembourg tax considerations relating to the Notes. It specifically contains information on taxes on the income from the Notes withheld at source and provides an indication as to whether the Issuer assumes responsibility for the withholding of taxes at the source. It does not purport to be a complete analysis of all tax considerations relating to the Notes. Prospective purchasers of the Notes should consult their own tax advisors with respect to particular circumstances, the effect of state, local or foreign laws to which they may be subject and as to their tax position. This summary is based upon the law as in effect on the date of this Prospectus. The information contained within this section is limited to withholding taxation issues, and prospective investors should not apply any information set out below to other areas, including (but not limited to) the legality of transactions involving the Notes.

Withholding Tax and Self-applied Levy

Under Luxembourg tax law currently in effect and with the possible exception of interest paid to certain individual Holders or so-called residual entities, there is no Luxembourg withholding tax on payments of interest (including accrued but unpaid interest). There is also no Luxembourg withholding tax, with the possible exception of payments made to certain individual Holders or so-called residual entities, upon repayment of principal in case of reimbursement, redemption, repurchase or exchange of the Notes.

Resident Holders

Under the Luxembourg law dated December 23, 2005 (hereafter, the "**Law**"), a 10% Luxembourg withholding tax is levied as of January 1, 2006 on interest payments or similar income payments (accrued since July 1, 2005) made by Luxembourg paying agents to (or for the benefit of) Luxembourg individual residents. This withholding tax also applies on accrued interest received upon disposal, redemption or repurchase of the Notes. Such withholding tax will be in full discharge of income tax if the beneficial owner is an individual acting in the course of the management of his/her private wealth. Responsibility for withholding such 10% withholding tax will be assumed by the Luxembourg paying agent.

Further, pursuant to the Law as amended by the law of July 17, 2008, Luxembourg resident individuals who are the beneficial owners of interest payments and other similar income made by a paying agent established outside Luxembourg in a Member State of the European Union or of the European Economic Area or in a jurisdiction having concluded an agreement with Luxembourg in connection with the EU Savings Directive as defined hereinafter, may also opt for a final 10% levy. In such case, the 10% levy is calculated on the same amounts as for the payments made by Luxembourg resident paying agents. The option for the 10% levy must cover all interest payments made by the paying agent to the Luxembourg resident beneficial owner during the entire civil year.

Non-resident Holders

Under the Luxembourg tax law currently in effect and subject to the application of the Luxembourg laws dated June 21, 2005, as amended (the "**Laws**") implementing the European Council Directive 2003/48/EC on the taxation of savings income (the "**EU Savings Directive**") and several agreements concluded between Luxembourg and certain dependant territories of the European Union, there is no withholding tax on payments of interest (including accrued but unpaid interest) made to a Luxembourg non-resident Holder. Under the Laws, a Luxembourg based paying agent (within the meaning of the EU Savings Directive) is required since July 1, 2005, to withhold tax on interest and other similar income (including reimbursement premium received at maturity) paid by it to (or under certain circumstances, to the benefit of) an individual or a residual entity ("**Residual Entity**") in the sense of article 4.2. of the EU Savings Directive (*i.e.* an entity without legal personality, except for (1) a Finnish *avoin yhtiö* and *kommandiittiyhtiö* / *öppet bolag* and *kommanditbolag* and (2) a Swedish *handelsbolag* and *kommanditbolag*, and whose profits are not taxed under the general arrangements for the business taxation and that is not, or has not opted to be considered as, a UCITS recognised in accordance with Council Directive 2009/65/EC), resident or established in another Member State of the European Union unless the beneficiary of the interest payments elects for an exchange of information or, in case of an individual beneficiary, the tax certificate procedure. The same regime applies to payments to individuals or Residual Entities resident or established in any of the following territories: Aruba, British Virgin Islands, Curaçao, Guernsey, the Isle of Man, Jersey, Montserrat and Sint Maarten.

The withholding tax is currently 35%. Responsibility for withholding such 35% tax will be assumed by the Luxembourg paying agent. The withholding tax system will only apply during a transitional period, the ending of which depends on the conclusion of certain agreements relating to information exchange with certain third countries.

The Council of the European Union adopted certain amendments to the EU Savings Directive, which will, upon implementation, amend or broaden the scope of the requirements described above.

The Luxembourg government has announced its intention to elect out of the withholding system in favour of an automatic exchange of information with effect as from 1 January 2015.

Austria

The following summary does not purport to be a comprehensive description of all Austrian tax considerations that may be relevant for the decision to acquire, to hold, and to dispose of the Securities and does not constitute legal or tax advice. The summary is based on Austrian tax law and practice and official interpretation currently in effect, all of which are subject to change. Future legislative, judicial or administrative changes could modify the tax treatment described below and could affect the tax consequences for investors. The discussion of certain Austrian taxes set forth below is included for information purposes only.

This overview of Austrian tax issues is based on the assumption that the Notes are legally and actually publicly offered in the form of securities and do not qualify as equity or units in a non-Austrian investment fund for Austrian tax purposes. The tax consequences may substantially differ if the Notes are not legally and factually publicly offered in the form of securities or if the Notes are qualified as equity instruments or (in particular if issued by a non-Austrian entity) units in a non-Austrian investment fund within the meaning of § 188 of the Austrian Investment Fund Act (*Investmentfondsgesetz, InvFG*).

Tax Residents

Income from the Notes derived by individuals, whose domicile or habitual abode is in Austria, is subject to Austrian income tax pursuant to the provisions of the Austrian Income Tax Act (*Einkommensteuergesetz; EStG*). Interest income from the Notes as well as income from realised capital gains (*Einkünfte aus realisierten Wertsteigerungen*) from the Notes are subject to a special income tax rate of 25%. A realised capital gain means any income derived from the sale or redemption of the Notes. The tax base is, in general, the interest paid or, with respect to capital gains, the difference between the sale proceeds or the redemption amount, in each case including accrued interest, and the acquisition costs including accrued interest. For Notes held as private assets, the acquisition costs shall not include incidental acquisition costs. For the calculation of the acquisition costs of Notes held within the same securities account and having the same securities identification number but which are acquired at different points in time, an average price shall apply. Expenses which are directly connected with income subject to the special tax rate of 25% are not deductible.

If interest is paid by an Austrian paying agent (*auszahlende Stelle*; e.g., an Austrian bank or an Austrian branch of foreign bank), such interest income is subject to Austrian withholding tax (*Kapitalertragsteuer*) at a rate of 25% to be withheld by the paying agent. The income tax for interest income generally constitutes a final taxation (*Endbesteuerung*) for individuals, irrespective whether the Notes are held as private assets or as business assets. In case of income from realised capital gains, withholding tax at a rate of 25% is to be withheld if the Notes are either deposited with an Austrian securities depository (*depotführende Stelle*) or, if the Notes are deposited with a non-Austrian securities depository, if the non-Austrian securities depository is a branch or group company of an Austrian paying agent and if such paying agent processes the payment, pays out or settles the capital gain in cooperation with the non-Austrian securities depository. In case of realised capital gains, the 25% withholding tax deduction will result in final income taxation only for individuals holding the Notes as private assets provided that the investor has evidenced the factual acquisition costs of the Notes to the securities depository. Capital gains realised as business income or employment income need to be included in the income tax return and are subject to an income tax rate of 25%.

If interest income or income from realised capital gains are not subject to Austrian withholding tax (e.g., because there is no Austrian securities depository or paying agent), the taxpayer will have to include the interest income or income from realised capital gains derived from the Notes in his personal income tax return pursuant to the provisions of the Austrian Income Tax Act, unless a Swiss or Liechtenstein paying agent has withheld final withholding tax under the respective Swiss or Liechtenstein withholding tax acts implementing the bilateral withholding tax agreements with Switzerland (in force since 1 January 2013) and Liechtenstein (in force since 1 January 2014) which final withholding tax discharges the investor's Austrian income tax liability.

Income from Notes which are not legally or actually publicly offered within the meaning of the Austrian Income Tax Act would not be subject to withholding tax and final taxation but subject to normal progressive personal income tax rates of up to 50%.

Withdrawals (*Entnahmen*) and other transfers of Notes from the securities account will be treated as disposals (sales), unless specified exemptions pursuant to § 27(6)(1)(a) EStG will be fulfilled such as the transfer of the Notes to a securities account owned by the same taxpayer (i) with the same Austrian securities depository (bank), (ii) with another Austrian bank if the account holder has instructed the transferring bank to disclose the acquisition costs to the receiving bank or (iii) with a non-Austrian bank, if the account holder has instructed the transferring bank to transmit the pertaining information to the competent tax office or has, in the case of transfers from a

foreign account, himself notified the competent Austrian tax office within a month; or like the transfer without consideration to a securities account held by another taxpayer, if the fact that the transfer has been made without consideration has been evidenced to the bank or the bank has been instructed to inform the Austrian tax office thereof or if the taxpayer has himself notified the competent Austrian tax office within a month. Special rules apply if a taxpayer transfers his/her residence outside of Austria or Austria loses for other reasons its taxation right in respect of the Notes to other countries (which gives rise to a deemed capital gain and exit taxation with the option for deferred taxation in the case of a transfer to an EU member state or certain member states of the European Economic Area).

Losses from Notes held as private assets may only be set off with other investment income subject to the special 25% tax rate (excluding, inter alia, interest income from bank deposits and other claims against banks) and must not be set off with any other income. Pursuant to § 93(6) EStG, Austrian securities depositories have to apply a mandatory set-off of losses from securities accounts of the same taxpayer at the same securities depository (subject to certain exemptions). A carry-forward of such losses is not permitted.

Taxpayers, whose regular personal income tax is lower than 25% may opt for taxation of the income derived from the Notes at the regular personal income tax rate. Any tax withheld will then be credited against the income tax. Such application for opting into taxation at the regular personal income tax rate must, however, include all income subject to the special 25% tax rate. Expenses in direct economic connection with such income are also not deductible if the option for taxation at the regular personal income tax rate is exercised.

If Notes are held as business assets, acquisition cost may also include incidental acquisition costs. Interest and realised capital gains derived from the Notes are also subject to the special income tax rate of 25% deducted by way of the withholding tax. However, realised capital gains, contrary to interest income, are not subject to final taxation and have to be included in the tax return. Write-downs and losses derived from the sale or redemption of Notes held as business assets must primarily be set off against positive income from realised capital gains of financial instruments of the same business and only half of the remaining loss may be set off or carried forward against any other income.

A corporation subject to unlimited corporate income tax liability in Austria will be subject to Austrian corporate income tax at a rate of 25%. Any Austrian withholding tax levied is credited as prepayment against the Austrian corporate income tax amount. A corporation may file an exemption declaration pursuant to § 94(5) EStG in order to avoid that Austrian withholding tax is levied. Tax losses may generally be offset against all other income. Tax loss carry forwards are generally possible.

Non-residents

Income including capital gains derived from the Notes by individuals who do not have a domicile or their habitual abode in Austria ("**non-residents**") is currently not taxable in Austria provided that the income is not attributable to an Austrian permanent establishment and provided that the EU Savings Directive is not applicable (for withholding tax under the EU Savings Directive see below). An Austrian paying agent or securities depository may abstain from levying 25% withholding tax under § 94(13) EStG. Draft legislation would, if enacted, extend the limited Austrian tax liability to interest within the meaning of the Austrian EU-Source Tax Act (*EU-Quellensteuergesetz; EU-QuStG*) received by a recipient not covered by EC Council Directive 2003/48/EC ("**EU Savings Directive**") as of 1 January 2015. It is a prerequisite that the obligation to levy 25% Austrian withholding tax is triggered. This is especially the case if interest is paid by an Austrian resident paying agent. Interest payable by debtors having neither their domicile nor place of management nor seat in Austria nor an Austrian branch (relevant only if the non-Austrian debtor is a non-Austrian credit institution) as well as interest on claims entered into a public debt registry are exempt from limited Austrian tax liability and from withholding tax, even if the interest is paid by an Austrian paying agent.

If any Austrian withholding tax is deducted by the securities depository or paying agent, the tax withheld shall be refunded to the non-resident holder upon his application which has to be filed with the competent Austrian tax authority within five calendar years following the date of the imposition of the withholding tax. Where non-residents receive income from the Notes as part of business income taxable in Austria (e.g., permanent establishment), they will, in general, be subject to the same tax treatment as resident investors.

Other taxes

There should be no transfer tax, registration tax or similar tax payable in Austria by Holders as a consequence of the acquisition, ownership, disposition or redemption of the Notes. The Austrian inheritance and gift tax (*Erbschafts- und Schenkungssteuer*) was abolished with effect as of August 1, 2008. However, gifts from or to Austrian residents have to be notified to the tax authorities within a three-month notification period. There are certain exemptions from such notification obligation, e.g., for gifts among relatives that do not exceed an aggregate

amount of EUR 50,000 per year or gifts among unrelated persons that do not exceed an aggregate amount of EUR 15,000 within five years.

Austrian implementation of the EU Savings Directive

Under the Austrian EU-Source Tax Act implementing the **EU Savings Directive**, interest paid by an Austrian paying agent to an individual beneficial owner resident in another EU member state is subject to EU source tax at a rate of 35 per cent Interest within the meaning of the EU-QuStG are, among others, interest paid or credited to an account, relating to debt claims of every kind, whether or not secured by mortgage and whether or not carrying a right to participate in the debtor's profits, and, in particular, income from government securities and income from bonds or debentures, including premiums and prizes attaching to such securities, bonds or debentures.

An exemption from EU source taxation applies, among others, if the beneficial owner of the interest forwards to the Austrian paying agent documentation issued by the tax office where the tax payer is resident, stating (a) the beneficial owner's name, address and tax identification number (in the absence of a tax identification number the beneficial owner's date and place of birth), (b) the paying agent's name and address (c) the beneficial owner's address and account number or the security identification number. Further, EU source tax is not triggered if interest within the meaning of the EU-QuStG is paid to an institution within the meaning of § 4(2) EU-QuStG resident in another EU Member State and this institution agrees upon written request of the Austrian paying agent to enter into a simplified information exchange procedure with the Austrian paying agent. Special rules apply to securities the value of which depends directly on the value of a reference underlying. Distinction must be made between securities providing for capital protection to the investor (guaranteed interest is sufficient to constitute a capital protection within the present context) or not (see Information of the Austrian Federal Ministry of Finance dated 1 August 2005 for details).

The Netherlands

For the purposes of this section, the "Netherlands" shall mean that part of the Kingdom of the Netherlands that is in Europe.

Withholding tax

All payments made by the Issuer under the Notes may be made free of withholding or deduction of, for or on account of any taxes of whatever nature imposed, levied, withheld or assessed by The Netherlands or any political subdivision or taxing authority thereof or therein.

EU Savings Directive

Under the EU Savings Directive, Member States are required to provide to the tax authorities of another Member State details of payments of interest or similar income (similar income for this purpose includes, but is not limited to, payments on redemption of the Notes representing any discount on the issue of the Notes or any premium payable on redemption) paid by a person within its jurisdiction to an individual resident in that other Member State or to certain limited types of entities established in that other Member State. However, for a transitional period, Luxembourg and Austria are instead required (unless during that period they elect otherwise) to operate a withholding system in relation to such payments (the ending of such transitional period being dependent upon the conclusion of certain other agreements relating to information exchange with certain other countries). On 10 April 2013, the Luxembourg government announced its intention to opt out of the withholding system in favour of automatic exchange of information with effect from 1 January 2015. Austria is expected to provide for an automatic exchange of information with effect as from 1 January 2016 or 2017.

A number of non-EU countries and territories (including Switzerland) have adopted similar measures (a withholding system in the case of Switzerland).

If a payment were to be made or collected through a Member State which has opted for a withholding system, or through a non-EU country which has adopted similar measures and has opted for a withholding system, or through certain dependent or associated territories which have adopted similar measures and which have opted for a withholding system, and an amount of, or in respect of, tax were to be withheld from that payment, neither the Issuer nor any Paying Agent nor any other person would be obliged to pay additional amounts with respect to any Note as a result of the imposition of such withholding tax. The Issuer is required to maintain a Paying Agent in a Member State that will not be obliged to withhold or deduct tax pursuant to the EU Savings Directive.

On 24 March 2014, the Council of the European Union adopted a directive amending the EU Savings Directive, which, when implemented, will enlarge the scope of the EU Savings Directive and require that additional steps be taken by tax authorities in certain circumstances to identify the beneficial owner of interest payments, using a "look-through" approach. The Member States will have until 1 January 2016 to adopt the national legislation necessary to comply with the amending directive and the national legislation must apply from 1 January 2017.

The proposed Financial Transaction Tax

The European Commission has published a proposal for a Directive for a common financial transaction tax (the "FTT") in certain participating Member States, including amongst others Austria, Belgium and Germany. The proposed FTT has very broad scope and could apply to certain dealings in financial instruments (including secondary market transactions).

The FTT as originally proposed could apply to persons both within and outside of the participating Member States. Generally, it would apply to certain dealings in financial instruments where at least one party is a financial institution, and either (i) at least one party is established or deemed to be established in a participating Member State or (ii) the financial instruments are issued in a participating Member State.

According to a recent press announcement of the EU Council, ten participating Member States intend to introduce an amended FTT as of 1 January 2016. Compared to the original proposal, the new proposal for a FTT has a limited scope only and shall only apply to shares and derivatives.

However, many details remain unclear and the currently proposed FTT might also be altered again prior to any implementation. In addition, the proposed Directive remains subject to negotiation between the participating Member States and was (and most likely will be) the subject of legal challenge.

SUBSCRIPTION, SALE AND OFFER OF THE NOTES

General

Commerzbank Aktiengesellschaft, ING Bank N.V., The Royal Bank of Scotland plc and UniCredit Bank AG (together, the "**Joint Lead Managers**") and Bayerische Landesbank Anstalt des öffentlichen Rechts (the "**Co-Lead Manager**") and together with the Joint Lead Managers the "**Managers**" and each a "**Manager**") will, pursuant to a subscription agreement to be signed on or about 26 May 2014 (the "**Subscription Agreement**"), agree, subject to certain closing conditions to subscribe, on a firm commitment basis, or procure subscribers for the Notes to be issued by the Issuer. The Managers will be entitled, under certain circumstances, to terminate the agreement reached with the Issuer. In such event, no Notes will be delivered to investors. Furthermore, the Issuer will agree to indemnify the Managers against certain liabilities in connection with the offer and sale of the Notes.

The fees payable to the Managers in connection with the offering, placement and subscription of the Notes will be up to 0.35 per cent. of the aggregate principal amount of the Notes.

The Managers or their affiliates have provided from time to time, and expect to provide in the future, investment services to the Issuer and its affiliates, for which the Managers or their affiliates have received or will receive customary fees and commissions.

There are no interests of natural and legal persons other than the Issuer and the Managers involved in the issue, including conflicting ones that are material to the issue.

Offer of the Notes

Public offer, offer period and determination of pricing details

The Notes will be offered to institutional investors and retail investors in compliance with applicable public offer restrictions by the Managers during an offer period which will commence on or about 22 May 2014 and will be open until and including 28 May 2014 subject to a shortening or extension agreed by the Issuer and the Joint Lead Managers. Should the Issuer and the Joint Lead Managers determine any shortening or extension of the offer period (e.g., due to changing market conditions), such changes will be published on the website of the Luxembourg Stock Exchange (www.bourse.lu).

The Notes may be offered to the public in each of Germany, Luxembourg, Austria and The Netherlands following the effectiveness of the notification of the Prospectus by the CSSF according to Article 18 of the Prospectus Directive.

The aggregate principal amount of Notes to be issued will be determined on the basis of the number and volume of orders received which offer a yield acceptable to the Issuer. The Issue Price and the interest rate will be determined as described in "Method of determination of the pricing details" below on the pricing date which is expected to be on or about 22 May 2014 (the "**Pricing Date**"). Such information as well as the number of Notes to be issued, the issue proceeds and the yield of the Notes will be set out in a notice (the "**Pricing Notice**") which will be filed with the CSSF and published on the website of the Luxembourg Stock Exchange (www.bourse.lu) on or after the Pricing Date and prior to the Issue Date. Any sale of the Notes on the secondary market will be subject to market conditions.

Conditions of the offer

There are no conditions to which the offer is subject.

Subscription rights for the Notes will not be issued. Therefore, there are no procedures in place for the exercise of any right of pre-emption, the negotiability of subscription rights and the treatment of subscription rights not exercised.

Technical details of the offer

During the offer period investors may submit offers to purchase Notes to the Managers using the information system Bloomberg or any other commonly used information systems. In the case of an order prior to the determination of the pricing details, the investors shall specify at which price they would be prepared to purchase which amount of Notes. Following determination and notification of the pricing details the Managers will offer the Notes upon request in Germany, Luxembourg, Austria and The Netherlands.

Method of determination of the pricing details

The Issue Price and the interest rate will be determined on the Pricing Date on the basis of a yield which is determined by adding a credit spread (the "**Pricing Credit Spread**") to the level of the Midswaps (as defined below) at the time of pricing. The Pricing Credit Spread will be fixed on the basis of the orders received and confirmed by the Managers. The level of the Midswaps will be determined as the average yield of the bid and ask prices of Interest-Swap Transactions ("**Midswaps**") with a maturity similar to the maturity of the Notes shown on Bloomberg page ICAE1 or on any other screen page which is conventionally used to price Eurobond transactions at the time of pricing.

The resulting yield will be used to determine the Issue Price (which is expected to be less than par) and the rate of interest (which is expected to be a percentage figure which can be evenly divided by 1/8 of a full per cent. and which will be correspondingly higher if a higher Issue Price is determined and which will be correspondingly lower if a lower Issue Price is determined), all to correspond to the yield which reflects the level of the Midswaps and the Pricing Credit Spread.

Confirmation of offers placed by, and allotments to, investors

Each investor who has submitted an order in relation to the Notes and whose order is accepted by the Joint Lead Managers will receive a confirmation by electronic mail, fax or through commonly used information systems setting out its respective allotment of Notes. Before an investor receives a confirmation from the Joint Lead Managers that its offer to purchase Notes has been accepted, the investor may reduce or withdraw its purchase order.

Delivery of the Notes to investors

Following the determination of the pricing details and confirmation which orders have been accepted and which amounts have been allotted to particular investors, delivery and payment of the Notes will generally be made within four business days after the date of pricing of the Notes and the confirmation of the allotment to investors. The Notes so purchased will be delivered via book-entry through the Clearing Systems (see "*GENERAL INFORMATION – Clearing and Settlement*") and their depository banks against payment of the Issue Price.

Costs and expenses relating to the offer

The Issuer will not charge any costs, expenses or taxes directly to any investor. Investors must, however, inform themselves about any costs, expenses or taxes in connection with the Notes which are generally applicable in their respective country of residence, including any charges their own depository banks charge them for purchasing or holding securities.

Consent to the use of the Prospectus

Each Manager and each further financial intermediary subsequently reselling or finally placing the Notes is entitled to use the Prospectus in Luxembourg, Germany, Austria and The Netherlands for the subsequent resale or final placement of the Notes during the period commencing on the later of (and including) (i) 22 May 2014 and (ii) the date of the publication of the Pricing Notice following its publication and ending on (and including) 4 June 2014 during which subsequent resale or final placement of the Notes can be made, provided however, that the Prospectus is still valid in accordance with Article 11 of the Luxembourg Prospectus Law. The Issuer accepts responsibility for the information given in this Prospectus also with respect to such subsequent resale or final placement of the Notes.

The Prospectus may only be delivered to potential investors together with all supplements published before such delivery in accordance with Art. 13 of the Luxembourg Prospectus Law. Any supplement to the Prospectus in accordance with Art. 13 of the Luxembourg Prospectus Law will be available for viewing in electronic form on the website of the Luxembourg Stock Exchange (www.bourse.lu).

When using the Prospectus, each relevant further financial intermediary must make certain that it complies with all applicable laws and regulations in force in the respective jurisdictions.

In the event of an offer being made by a further financial intermediary, such further financial intermediary shall provide information to investors on the terms and conditions of the Notes at the time of that offer.

Any further financial intermediary using the Prospectus shall state on its website that it uses the Prospectus in accordance with the consent of the Issuer and the conditions attached to this consent.

Selling Restrictions

General

Each Manager has acknowledged that other than explicitly mentioned in this Prospectus no action is taken or will be taken by the Issuer in any jurisdiction that would permit a public offering of the Notes, or possession or distribution of any offering material relating to them, in any jurisdiction where action for that purpose is required.

Each Manager has represented and agreed that it will comply with all applicable laws and regulations in each jurisdiction in which it purchases, offers, sells or delivers Notes or has in its possession or distributes any offering material relating to them.

European Economic Area

In relation to each Member State of the European Economic Area which has implemented the Prospectus Directive (each, a "**Relevant Member State**"), each Manager has represented, warranted and agreed that with effect from and including the date on which the Prospectus Directive is implemented in that Relevant Member State (the "**Relevant Implementation Date**") it has not made and will not make an offer of Notes which are subject to the offering contemplated by this Prospectus to the public in that Relevant Member State prior to the publication of a prospectus in relation to the Notes which has been approved by the competent authority in that Relevant Member State in accordance with the Prospectus Directive or, where appropriate, published in another Relevant Member State and notified to the competent authority in that Relevant Member State in accordance with Article 18 of the Prospectus Directive, provided that the Issuer has consented in writing to the use of the Prospectus for any such offers, except that it may, with effect from and including the Relevant Implementation Date, make an offer of Notes to the public in that Relevant Member State at anytime:

- (a) to any legal entity which is a qualified investor as defined in the Prospectus Directive;
- (b) to fewer than 100, or, if the Relevant Member State has implemented the relevant provision of the 2010 PD Amending Directive, 150 natural or legal persons (other than qualified investors as defined in the Prospectus Directive), as permitted under the Prospectus Directive, subject to obtaining the prior consent of the Managers; or
- (c) in any other circumstances which do not require the publication by the Issuer of a prospectus pursuant to Article 3 of the Prospectus Directive;

provided that no such offer of the Notes shall require the Issuer or any Manager to publish a prospectus pursuant to Article 3 of the Prospectus Directive or supplement this Prospectus pursuant to Article 16 of the Prospectus Directive.

For the purposes of this provision, the expression an "**offer of Notes to the public**" in relation to any Notes in any Relevant Member State means the communication in any form and by any means of sufficient information on the terms of the offer and the Notes to be offered so as to enable an investor to decide to purchase or subscribe the Notes, as the same may be varied in that Relevant Member State by any measure implementing the Prospectus Directive in that Relevant Member State, and the expression "**Prospectus Directive**" means Directive 2003/71/EC (and amendments thereto, including the 2010 PD Amending Directive, to the extent implemented in the Relevant Member State) and includes any relevant implementing measure in each Relevant Member State, and the expression "**2010 PD Amending Directive**" means Directive 2010/73/EU.

United States and its Territories

The Notes have not been and will not be registered under the Securities Act and may not be offered, sold or delivered within the United States except pursuant to an exemption from, or in a transaction not subject to, the registration requirements of the Securities Act. Each Manager represents that it has not offered or sold, and agrees that it will not offer or sell, any Notes constituting part of its allotment within the United States except in accordance with Rule 903 of Regulation S under the Securities Act. Accordingly, neither it, its affiliates, nor any persons acting on its or their behalf have engaged or will engage in any directed selling efforts with respect to the Notes. Terms used in this paragraph have the meanings given to them by Regulation S.

In addition, each Manager has represented, warranted and agreed that, except to the extent permitted under U.S. Treasury Regulations section 1.163-5(c)(2)(i)(D) (the "**D Rules**"):

- (a) it has not offered or sold Notes, and during the restricted period shall not offer or sell Notes, directly or indirectly to a United States person or to a person who is within the United States or its possessions, and

it has not delivered and shall not deliver within the United States or its possessions Notes that are sold during the restricted period;

- (b) it has and throughout the restricted period it shall have in effect procedures reasonably designed to ensure that its employees or agents who are directly engaged in selling Notes are aware that the Notes may not be offered or sold during the restricted period to a United States person or to a person who is within the United States or its possessions, except as permitted by the D Rules;
